5 COMMITTEE SUBSTITUTE FOR SENATE BILL NO. 659 - By: EASON McINTYRE of
6 the Senate and ELLIS of the House.

7 An Act relating to the Oklahoma Historical Society; creating
8 the Buffalo Soldiers Heritage Corridor; stating purpose;
9 specifying program parameters; creating advisory committee;
10 stating duties; specifying term; providing for staffing;
11 creating the Buffalo Soldiers Heritage Corridor Fund;
12 providing for expenditures; providing for codification; and
13 providing an effective date.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. NEW LAW A new section of law to be codified
16 in the Oklahoma Statutes as Section 7.1 of Title 53, unless there is
17 created a duplication in numbering, reads as follows:

18 A. There is hereby created within the Oklahoma Historical
19 Society the Buffalo Soldiers Heritage Corridor.

20 B. The purpose of the Buffalo Soldiers Heritage Corridor is to
21 encourage the development and appreciation of historic sites,
22 museums, and heritage programs associated with the story of the
23 Buffalo Soldiers and their legacy of patriotic service, sacrifice,
24 and struggle for the fundamental rights and responsibilities of
25 every American citizen.

1 C. Furthermore, the Corridor is to encourage heritage tourism
2 that will attract visitors to Oklahoma and lead them to communities
3 where the stories of the Buffalo Soldiers and their legacy are still
4 evident today.

5 SECTION 2. NEW LAW A new section of law to be codified
6 in the Oklahoma Statutes as Section 7.2 of Title 53, unless there is
7 created a duplication in numbering, reads as follows:

8 A. The Corridor shall be a cooperative program administered by
9 the Oklahoma Historical Society to focus resources on the shared
10 theme of Buffalo Soldiers within a fixed geographical area.

11 B. The Corridor shall be a private-public partnership between
12 federal, state, county, municipal, tribal, nonprofit organizations,
13 and private individuals who share the responsibility for preserving
14 and promoting the story of the Buffalo Soldiers.

15 C. All participating communities and organizations shall share
16 a common heritage of the African-American soldiers who served their
17 country in the military and contributed to the development of farms
18 and ranches owned by the Freedmen of the Five Civilized Tribes, the
19 All-Black Towns of Oklahoma, and the Greenwood District of Tulsa.

20 D. The Corridor, as administered by the Historical Society,
21 shall encompass the following communities and sites: Tulsa, Cabin
22 Creek, Fort Gibson, Honey Springs Battlefield, Muskogee,

1 Rentiesville, Taft, Grayson, Clearview, and Boley. Others along the
2 corridor will be encouraged to participate in the program.

3 E. The partners in the Corridor, subject to funding, shall
4 participate in events, programs, signage, and interpretive markers
5 administered by the Oklahoma Historical Society.

6 F. The partners in the Corridor, subject to funding, shall
7 participate in promotional brochures and regional, national, and
8 international marketing efforts administered by the Oklahoma Tourism
9 and Recreation Department.

10 SECTION 3. NEW LAW A new section of law to be codified
11 in the Oklahoma Statutes as Section 7.3 of Title 53, unless there is
12 created a duplication in numbering, reads as follows:

13 A. The Executive Director of the Oklahoma Historical Society
14 shall appoint an Advisory Committee of at least five persons from
15 the participating partners that shall consist of one person from the
16 Oklahoma Tourism and Recreation Department, one person from the
17 Oklahoma Historical Society, one person from the Greenwood Cultural
18 District, one person from the All-Black Towns, and one or more
19 persons from the public at large.

20 B. The Advisory Committee shall contribute input to the
21 development of a master plan for the Corridor, offer guidance to
22 professional staff as programs are developed, and seek additional
23 partners and resources for the cooperative effort.

1 C. The Advisory Committee members' terms shall be for three (3)
2 years.

3 D. Each member of the Advisory Committee shall serve without
4 compensation except that each member of the Committee shall receive
5 reimbursement for travel expenses in accordance with the State
6 Travel Reimbursement Act.

7 E. Staffing for the Corridor and Advisory Committee shall be
8 provided by the Oklahoma Historical Society.

9 SECTION 4. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 7.4 of Title 53, unless there is
11 created a duplication in numbering, reads as follows:

12 A. There is hereby created in the State Treasury a revolving
13 fund for the Oklahoma Historical Society to be designated the
14 "Buffalo Soldiers Heritage Corridor Fund." The fund shall be a
15 continuing fund, not subject to fiscal year limitations and shall
16 consist of all monies deposited to the fund by law, as well as
17 gifts, donations, and private, state, and federal funds designated
18 for the deposit thereto.

19 B. All monies accruing to the credit of such fund are hereby
20 appropriated and may be budgeted and expended by the Oklahoma
21 Historical Society for the purpose of providing for the programs and
22 direct costs of the Buffalo Soldiers Heritage Corridor.

1 C. Expenditures from such fund shall be made upon warrants
2 issued by the State Treasurer against claims filed as prescribed by
3 law with the Director of the Office of State Finance for approval
4 and payment.

5 SECTION 5. This act shall become effective November 1, 2005.
