

An Act relating to revenue and taxation; providing tax credit for purchase or construction of dry fire hydrants; limiting amount of credit; providing qualifications for dry fire hydrants; prohibiting credit from exceeding tax liability; providing for carryover of credit; requiring promulgation of rules; defining term; providing for codification; and providing an effective date.
