

An Act relating to motor vehicles; amending 47 O.S. 2001, Sections 6-103, as last amended by Section 3, Chapter 392, O.S.L. 2003, 6-103.1, 6-105, as last amended by Section 1, Chapter 139, O.S.L. 2004, 6-107, as amended by Section 16, Chapter 397, O.S.L. 2002, 6-107.3, 6-107.4, 6-107.5 and 6-110.2, as amended by Section 1, Chapter 219, O.S.L. 2003 (47 O.S. Supp. 2004, Sections 6-103, 6-105, 6-107 and 6-110.2), which relate to issuance, expiration, and renewal of licenses; modifying restriction for issuance of driver license to unemancipated person; clarifying language; modifying age requirement; modifying terms; stating exception to issuance of instruction permit, restricted Class D license, and special permit; modifying age requirement for certain application; requiring signature and verification on certain application; declaring signature as assumption of certain obligation; modifying age limitation for certain acts; clarifying language; modifying statutory references; clarifying language; modifying age limitation for certain defined terms; stating eligibility requirements for reinstatement of driving privileges; deleting obsolete language; modifying statutory references; clarifying language; amending 47 O.S. 2001, Section 6-111, as last amended by Section 4, Chapter 149, O.S.L. 2004 (47 O.S. Supp. 2004, Section 6-111), which relates to issuance of driver license, identification cards and temporary permits; requiring certain information appears on a driver license or identification card; permitting the Department to issue a nonresident commercial driver license to certain applicants; specifying eligible applicants; requiring certain wording on the face of the license; specifying period of validity; providing for a fee; requiring the surrender of certain nonresident commercial driver license; amending 47 O.S. 2001, Sections 6-205, as last amended by Section 6, Chapter 149, O.S.L. 2004, 6-205.1, as last amended by Section 7, Chapter 390, O.S.L. 2004, and 6-206, as amended by Section 16, Chapter 392, O.S.L. 2003 (47 O.S. Supp. 2004, Sections 6-205, 6-205.1 and 6-206), which relate to cancellation, suspension, or revocation of licenses; modifying offenses that require revocation of driving privileges; deleting proof of registration or ownership requirement; modifying time limitation for prior revocations; providing for suspension of driving privileges under certain circumstances; stating periods of suspension; requiring such period to be modified; amending 47 O.S. 2001, Section 754.1, as amended by Section 23, Chapter 418, O.S.L. 2004 (47 O.S. Supp. 2004, Section 754.1), which relates to modification of revocation or denial if no adequate transportation exists; expanding exception for employer-owned or leased vehicles; amending 47 O.S. 2001, Section 1151, as last amended by Section 24, Chapter 522, O.S.L. 2004 (47 O.S. Supp. 2004, Section 1151), which relates to offenses and penalties; modifying penalty for certain offense; and providing an effective date."
