

An Act relating to revenue and taxation; providing income tax credit for investment in certain property placed in service for use in refinery; specifying certain qualifications for credit to be received; limiting property upon which credit allowed; specifying amount of credit; allowing unused credit to be carried forward; specifying certain duties of Oklahoma Tax Commission; providing for codification; and providing an effective date.
