

An Act relating to revenue and taxation; amending 68 O.S. 2001, Section 2357.25, which relates to income tax credits; modifying specified purpose for investments by agricultural processing cooperatives, ventures and marketing associations; deleting obsolete language; modifying definition relating to certain marketing associations; and providing an effective date.
