

An Act relating to state government; creating the Oklahoma Tourism, Parks and Recreation Enhancement Act; creating the Oklahoma Tourism and Recreation Commission; creating the Oklahoma Tourism and Recreation Department; making references to certain entities to mean the Oklahoma Tourism and Recreation Commission or the Oklahoma Department of Commerce; stating purpose of the Commission and the Department; authorizing the Commission to set policy for the Department; providing for appointment of Commissioners; clarifying duties of Commissioners; authorizing the Commissioners to promulgate rules and policies; requiring the Commission to prepare and submit an annual report to the Governor and Legislature; authorizing Commission to appoint the Executive Director of the Oklahoma Tourism and Recreation Department; establishing criteria and duties of the Director; authorizing the Director to employ staff; authorizing the director to administer policies adopted by the Commission; authorizing the Director to enter into contracts; authorizes the Director to develop certain incentive plans; authorizing Division to sell advertising and negotiate rates; exempting certain sales of advertisement from the Central Purchasing Act and the Administrative Procedures Act; authorizing the Director to use certain funds for the furtherance of tourism; requiring approval of use of funds; requiring monthly audit; authorizing the Director to aid and assist in planning certain community recreational projects; authorizing the Director to employ certain legal personnel; authorizing the Attorney General to give official opinions and prosecute and defend actions of the Department or Commission; creating certain Divisions within the Department; authorizing the Commission to maintain possession and control of all state parks and certain other lands owned or leased by the Commission; authorizing Commission to acquire property under certain circumstances; authorizing the Commission to contract for certain feasibility studies; clarifying duties and immunities of the Division of State Parks; clarifying duties of Park Rangers; providing certain public access and use of facilities; stating certain prohibitions; providing for violation; setting fine; specifying certain monies collected to be deposited in certain fund; authorizing certain personnel to inspect and issue permits for watercraft and to collect fees; authorizing the Commission to offer, sell and execute mineral leases; specifying rules and regulations for the facilitation of the sale of mineral leases; stipulating each lease to contain certain provisions for the discovery of natural gas; requiring certain revenues to be dedicated to certain improvements; authorizing the Commission to establish rates for rooms at state lodges, golf course fees, and day-use charges for state parks; stating exceptions for certain persons; authorizing the Commission to utilize certain promotion programs; authorizing the Commission to sell certain real estate and setting forth requirements for sale; setting procedures for depositing monies in certain funds from sale of real estate; stating purpose of funds; authorizing the Commission to promulgate rules for the repayment of lease or rental agreement with concessionaires; authorizing the Commission to transfer interest in real or personal property owned by the State or Department to certain entities; stating parameters for certain real estate transfers; authorizing the Commission to establish a not-for-profit state park foundation; defining term; stating parameters for the state park foundation; requiring the Commission to construct, maintain and repair roads and parking areas in state parks; declaring state parks to be a state game refuges; requiring the Oklahoma Wildlife Conservation Commission to stock state parks with game and fish; allowing the Oklahoma Wildlife Conservation Commission and the Commission to authorize hunting in areas of certain state parks; authorizing the Commission to negotiate for the purchase of Turner Falls; clarifying the duties of the Division of Travel and Tourism; authorizing the Commission to

sponsor an annual tourism and recreation industry conference; authorizes state agencies and state-owned information centers to distribute certain promotional materials to inform and attract business, industry and tourists; authorizing the Department to develop rules to administer matching funds for allowable expenditures of certain funds given to multicounty organizations; defining terms; stating intent of the Legislature to promote tourism by multicounty organizations; setting parameters for receiving multicounty matching funds; authorizing the Department to deduct any obligations due to the state from multicounty organizations; creating the Office of the Oklahoma Film and Music Commission; clarifying the duties of the Oklahoma Film and Music Commission; providing for membership; authorizing the Oklahoma Today Magazine to sell advertising; requiring approval of advertising; providing for payments of commissions to certain employees of Oklahoma Today Magazine under certain circumstances; creating the Oklahoma Today Magazine Foundation; declaring merchandise purchased and resold through Oklahoma Today Magazine to be exempt from the Central Purchasing Act; requiring the Department to establish a cost and revenue reporting system; requiring the Department to have annual audit; stating parameters of the audit; authorizing the Department to employ certain employees who shall be seasonal; defining seasonal employees; stating certain employees not be subject to the Merit System of Personnel Administration; limiting expenditures for purchases in excess of certain amount; requiring approval by majority of Commission for certain expenditures; stating exemption for purchases less than a certain amount; setting procedures for uncollectable accounts receivable; authorizing the Department to purchase liability insurance; waiving performance bond requirement; authorizing the State Treasurer of Oklahoma to be ex-officio Treasurer of the Commission; requiring monies of the Commission to be disbursed on instruments signed by certain authorized persons; requiring the Commission to keep complete and accurate accounts of all transactions; creating the Oklahoma Tourism and Recreation Department Revolving Fund; creating the Oklahoma Today magazine Revolving Fund; creating the Tourism and Recreation Environmental Loan Proceeds Revolving Fund; Creating the Oklahoma State Parks Partnership Matching Revolving Fund; creating a petty cash fund in each revolving fund; limiting amount of purchase; providing for reimbursement; authorizing the Commission to negotiate bonds; stating purpose of bonds; stating terms, covenants and conditions; stating history of bond issues by the Commission; directing distribution of monies; authorizing the Commission to have the power to refund certain bonds; stating validity of signatures on bonds; authorizing the Commission to prescribe and collect fees and may pledge the revenues to the payment of bonds; authorizing the Commission to issue bonds to construct certain improvements; authorizing the Commission to issue bonds for the construction of tourism information centers; providing procedures for default on bonds; prohibiting the issuance of bonds until a certified copy of the proceedings authorizing the issuance is submitted to the Attorney General; construing language; prohibiting forced sale of property controlled and operated by the Commission; stating certain tax exemptions on property controlled and operated by the Commission; requiring all bonds to have certain information on the backs of the certificate; authorizing any bank, trust or insurance company organized under State law to invest in bonds; authorizing the Commission to issue bonds for the purpose of refunding obligations previously issued; authorizing the Commission to file with the Supreme Court of Oklahoma certain applications for the approval of bonds; stating duty of the Court; providing for notice; providing for hearing; directing revenues collected by the Commission to be held in certain funds; authorizing the Office of
