

An Act relating to public finance; amending 62 O.S. 2001, Section 41.5a, which relates to the Information Services Division; deleting a duty; expanding prohibition of agencies to expend state funds for certain services; clarifying certain nondisclosure provisions; amending 62 O.S. 2001, Section 41.5a-1, which relates to statement of charges for processing services; deleting provision pertaining to Department of Transportation Data Processing Planning Revolving Fund; amending 62 O.S. 2001, Section 41.5e, as amended by Section 1, Chapter 128, O.S.L. 2004 (62 O.S. Supp. 2004, Section 41.5e), which relates to long range electronic data processing plans; expanding types of electronic data processing applications to be included in a plan; amending 62 O.S. 2001, Sections 41.5f and 41.5g, which relate to the Oklahoma Integrated Central Systems Management Division; transferring duties to the Office of State Finance; correcting agency name; clarifying certain responsibilities; eliminating certain responsibilities of the Director of State Finance; amending 62 O.S. 2001, Section 41.5h, which relates to creation and maintenance of state central communication or intercommunication system; adding certain electronic communication services to be reimbursed; adding certain electronic communication services prohibited from installation without authorization of Director of State Finance; deleting obsolete language; amending 62 O.S. 2001, Section 41.5i, which relates to certain powers and duties of the Information Services of the Office of State Finance; adding certain electronic communications to certain long-term plans and standards; clarifying statutory reference; amending 62 O.S. 2001, Section 41.5j, which relates to certain authorization, long-range plans, costs and interagency contracts; adding certain electronic communications; making certain provisions applicable to OneNet; amending 62 O.S. 2001, Section 41.5l, which relates to the Centrex Revolving Fund; renaming the fund; adding a statutory reference; authorizing the Director of State Finance to establish certain other funds; amending 62 O.S. 2001, Section 41.5m, which relates to the Oklahoma Government Telecommunications Network; adding certain electronic communications to various provisions; amending 62 O.S. 2001, Section 41.5p, which relates to the state portal system; directing agencies, boards and commissions to use state website and adopt certain standards; amending 62 O.S. 2001, Section 41.5q, which relates to convenience fee for certain online transactions; excluding convenience fee from certain calculations; amending 62 O.S. 2001, Section 41.5s, which relates to the State Governmental Internet Applications Review Board; deleting a certain duty; clarifying statutory reference; amending Section 2, Chapter 128, O.S.L. 2004 (62 O.S. Supp. 2004, Section 41.5t), which relates to accessibility of information technology for individuals with disabilities; clarifying statutory reference; amending Section 4, Chapter 128, O.S.L. 2004 (62 O.S. Supp. 2004, Section 41.5t.1), which relates to definitions; clarifying statutory reference; amending 62 O.S. 2001, Section 41.5t.2, as amended by Section 2, Chapter 128, O.S.L. 2004 (62 O.S. Supp. 2004, Section 41.5t.2), which relates to Electronic and Information Technology Accessibility Advisory Council; clarifying statutory reference; repealing 62 O.S. 2001, Section 41.5o, which relates to converting computer systems by a certain date; providing an effective date; and declaring an emergency.
