AS INTRODUCED

An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the State Board of Education, the Oklahoma State Regents for Higher Education, the State Board of Career and Technology Education, the Oklahoma Arts Council, the Oklahoma Educational Television Authority, the Commissioners of the Land Office, the Oklahoma Department of Libraries, the Physician Manpower Training Commission, the Oklahoma Board of Private Vocational Schools, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Oklahoma Commission for Teacher Preparation, the Office of the State Auditor and Inspector, the Office of the State Bond Advisor, the Department of Central Services, the Oklahoma Department of Emergency Management, the State Election Board, the Ethics Commission, the Office of State Finance, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Office of Personnel Management, the Office of the Secretary of State, the Oklahoma State Senate, the Oklahoma Space Industry Development Authority, the Oklahoma Tax Commission, the Department of Transportation, the Office of the State Treasurer, the Oklahoma Health Care Authority, the State Department of Health, the J.D. McCarty Center for Children with Developmental Disabilities, the Department of Mental Health and Substance Abuse Services, the University Hospitals Authority, the Oklahoma Department of Veterans Affairs, the Oklahoma Commission on Children and Youth, the Office of Handicapped Concerns, the Oklahoma Human Rights Commission, the Department of Human Services, the Oklahoma Indian Affairs Commission, the Office of Juvenile Affairs, the State Department of Rehabilitation Services, the Oklahoma Department of Agriculture, Food, and Forestry, the Oklahoma Capitol Complex and Centennial Commemoration Commission, the Department of Commerce, the Oklahoma Conservation Commission, the Department of Consumer Credit, the Corporation Commission, the Department of Environmental Quality, the Oklahoma Historical Society, the Oklahoma Horse Racing Commission, the State Insurance Department, the J.M. Davis Memorial Commission, the Department of Labor, the Department of Mines, the Oklahoma Scenic Rivers Commission, the Oklahoma Tourism and Recreation Department, the

Oklahoma Water Resources Board, the Will Rogers Memorial Commission, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the Pardon and Parole Board, the Oklahoma State Bureau of Investigation, the State Fire Marshal, the Board of Medicolegal Investigations, the Council on Law Enforcement Education and Training, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Department of Public Safety, the Oklahoma Indigent Defense System, the Office of the Attorney General, the Court of Criminal Appeals, the Supreme Court, the Office of the Attorney General, the Workers' Compensation Court, the District Attorneys Council, the Workers' Compensation Court, the Supreme Court, the Council on Judicial Complaints, the Department of Human Services and the Department of Corrections; stating sums of the appropriations; stating purposes and restrictions; authorizing and requiring certain expenditures; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SUBCOMMITTEE ON EDUCATION

SECTION 1. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of One Billion Five Hundred Seventy-eight Million Three Hundred Thirty-three Thousand Six Hundred Seventy-two Dollars (\$1,578,333,672.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Education Reform Revolving Fund created in Section 41.29b of Title 62 of the Oklahoma Statutes, the sum of Four Hundred Sixty-seven Million Five Hundred Thirty-six Thousand Three Hundred Fifty-nine Dollars (\$467,536,359.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Two Million Nine Hundred Forty-five

Thousand Dollars (\$2,945,000.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2004, the sum of Two Million Two Hundred Twenty-two Thousand Five Hundred Ninety-four Dollars (\$2,222,594.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 5. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2006, from the Common Education Technology Revolving Fund of the State Treasury, the sum of Thirty-eight Million Six Hundred Ten Thousand One Hundred Thirty-two Dollars (\$38,610,132.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 6. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the "Jobs and Growth Tax Relief Fund" otherwise designated as Fund 720 within the Office of State Finance, the sum of Seventeen Million Dollars (\$17,000,000.00) or so much thereof as may be necessary for the support of public school activities.

SECTION 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the "Jobs and Growth Tax Relief Fund" otherwise designated as Fund 720 within the Office of State Finance, the sum of Thirty-three Million Dollars (\$33,000,000.00) or so much thereof as may be necessary for the purchase of textbooks.

SECTION 8. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2006, from the Oklahoma Education Lottery Trust Fund of the State Treasury, the sum of Twenty-eight Million Twenty-two Thousand One Hundred Thirty-nine

Dollars (\$28,022,139.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 9. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2006, from the Oklahoma Education Lottery Trust Fund of the State Treasury, the sum of Three Million One Hundred Thirteen Thousand Five Hundred Seventy-one Dollars (\$3,113,571.00) or so much thereof as may be necessary for transfer to the School Consolidation Assistance Fund.

SECTION 10. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2006, from the Oklahoma Education Lottery Trust Fund of the State Treasury, the sum of Three Million One Hundred Thirteen Thousand Five Hundred Seventy-one Dollars (\$3,113,571.00) or so much thereof as may be necessary for transfer to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

SECTION 11. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Seven Hundred Forty-seven Million Nine Hundred Fifty-six Thousand Six Hundred Forty-three Dollars (\$747,956,643.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 12. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2006, the sum of Thirty-eight Million Six Hundred Ten Thousand One Hundred Thirty-two Dollars (\$38,610,132.00) from the Higher Education Capital Revolving Fund of the State Treasury for

allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 13. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2006, the sum of Thirty-eight Million Six Hundred Ten Thousand One Hundred Thirty-two Dollars (\$38,610,132.00) from the Oklahoma Tuition Scholarship Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 14. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Thirteen Million Six Hundred Seventeen Thousand Eight Hundred Two Dollars (\$13,617,802.00) or so much thereof as may be necessary for expenditures in the Oklahoma Higher Learning Access Program.

SECTION 15. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2006, the sum of Twenty-eight Million Twenty-two Thousand One Hundred Thirty-nine Dollars (\$28,022,139.00) from the Oklahoma Education Lottery Trust Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Section 713 of Title 3A of the Oklahoma Statutes for tuition grants, loans and scholarships, construction of educational facilities, capital outlay projects, endowed chairs, and technology

programs administered by the Oklahoma State Regents for Higher Education.

SECTION 16. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2006, the sum of Five Million Five Hundred Eight-two Thousand One Hundred Ninety-eight Dollars (\$5,582,198.00) from the Oklahoma Higher Education Learning Trust Fund of the State Treasury or so much thereof as may be necessary for expenditures in the Oklahoma Higher Learning Access Program.

SECTION 17. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of One Hundred Twenty-four Million Three Hundred Eighty-six Thousand Two Hundred Fifty-nine Dollars (\$124,386,259.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Career and Technology Education by law.

SECTION 18. There is hereby appropriated to the Oklahoma Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Three Million Nine Hundred Forty-nine Thousand Three Hundred Twelve Dollars (\$3,949,312.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Arts Council by law.

SECTION 19. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Four Million Three Hundred Thirty Thousand Nine Hundred Twenty-nine Dollars (\$4,330,929.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 20. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Four Million Seven Hundred Thirty-seven Thousand One Hundred Twelve Dollars (\$4,737,112.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 21. There is hereby appropriated to the Oklahoma Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Six Million Three Hundred Two Thousand Six Hundred Four Dollars (\$6,302,604.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Libraries by law.

SECTION 22. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Four Million Six Hundred Forty-nine Thousand Three Hundred Sixty-nine Dollars (\$4,649,369.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 23. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2004, the sum of Three Hundred Eighty-seven Thousand Six Hundred Eight Dollars (\$387,608.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 24. There is hereby appropriated to the Oklahoma Board of Private Vocational Schools from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for

the fiscal year ending June 30, 2006, the sum of One Hundred Fifty-nine Thousand Four Hundred Ninety-three Dollars (\$159,493.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Board of Private Vocational Schools by law.

SECTION 25. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Six Million Seven Hundred Ten Thousand Six Hundred Forty-nine Dollars (\$6,710,649.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 26. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Eleven Million Seven Hundred Nine Thousand Nine Hundred Forty-two Dollars (\$11,709,942.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 27. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Two Million Fourteen Thousand Six Hundred Sixty-one Dollars (\$2,014,661.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

SUBCOMMITTEE ON GENERAL GOVERNMENT AND TRANSPORTATION

SECTION 28. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Five Million Three

Hundred Twenty-two Thousand Six Hundred Eighty-two Dollars (\$5,322,682.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 29. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2004, the sum of Four Hundred Fifty-four Thousand Five Hundred Seventy-five Dollars (\$454,575.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 30. There is hereby appropriated to the Office of the State Bond Advisor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of One Hundred Ninety-one Thousand Two Hundred Twelve Dollars (\$191,212.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Bond Advisor by law.

SECTION 31. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Eleven Million Three Hundred Forty-eight Thousand Two Hundred Twenty-two Dollars (\$11,348,222.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 32. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2004, the sum of Two Million Nine Hundred Ninety-five Thousand One Hundred Ninety-four Dollars (\$2,995,194.00) to be

transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 33. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Three Thousand Eight Hundred Eighty-four Dollars (\$3,884.00) or so much thereof as may be necessary to perform maintenance on the Veterans Memorial within the Capitol complex.

SECTION 34. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2004, the sum of One Hundred Fifty-one Thousand Five Hundred Eighteen Dollars (\$151,518.00) or so much thereof as may be necessary to maintain the Hissom Memorial Center.

SECTION 35. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of One Million Three Hundred Ten Thousand One Hundred Forty-five Dollars (\$1,310,145.00) or so much thereof as may be necessary for asbestos abatement programs and for the expenses of filing claims for reimbursement from the Manville Property Damage Settlement Trust. The monies designated in this section shall be expended exclusively for the purposes so stated and shall not be transferable.

SECTION 36. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2004, the sum of Five Hundred Seventy Thousand Four Hundred Ninety-one Dollars (\$570,491.00) or so much thereof as may

be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 37. There is hereby appropriated to the Oklahoma Department of Emergency Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2004, the sum of Seven Hundred Three Thousand Two Hundred Eight Dollars (\$703,208.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Emergency Management by law.

SECTION 38. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Seven Million Two Hundred Thirty-five Thousand One Hundred Ninety-three Dollars (\$7,235,193.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 39. There is hereby appropriated to the Ethics Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Four Hundred Ninety-two Thousand Two Hundred Seventy-seven Dollars (\$492,277.00) or so much thereof as may be necessary to perform the duties imposed upon the Ethics Commission by law.

SECTION 40. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Twelve Million Nineteen Thousand Seven Hundred Fifty-six Dollars (\$12,019,756.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 41. There is hereby appropriated to the Office of State Finance from any monies not otherwise appropriated from the Special

Cash Fund of the State Treasury, the sum of Eleven Million Dollars (\$11,000,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of State Finance by law.

SECTION 42. There is hereby appropriated to the Office of the Governor from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury, the sum of Twenty-two Million Five Hundred Seventy-seven Thousand Sixty-three Dollars (\$22,577,063.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Governor by law.

SECTION 43. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury, the following amount, or so much thereof as may be necessary to pay monthly salaries, per diem, and expenses of the members of the House of Representatives and the salaries of its employees, and such contingent expenses as may be ordered paid therefrom, including the preparation and printing of the journals and calendars of the House of Representatives, and including the preparation and printing of the permanent journals thereof, in accordance with the following amount herein set forth:

For expenses of personnel services (including retirement and insurance costs), including those of members, and employees of the House of Representatives, and expenses of maintenance and operation, including travel expenses, supplies, materials, printing, equipment, and printing of permanent journals; and for the renovation and modification of the House of Representatives area; and other necessary expenses	\$18,629,154.00

Claims and payrolls filed against the appropriation made to the House of Representatives for the fiscal year ending June 30, 2006, shall be approved by the Speaker of the House of Representatives.

SECTION 44. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Two Million Three Hundred Seventy-one Thousand Six Hundred Seventy-nine Dollars (\$2,371,679.00) or so much thereof as may be necessary to perform the duties imposed upon the Legislative Service Bureau by law.

SECTION 45. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Five Hundred Ninety-four Thousand One Hundred Four Dollars (\$594,104.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Criminal Justice Resource Center by law.

SECTION 46. There is hereby appropriated to the Office of the Lieutenant Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Five Hundred Thirty-four Thousand Seven Hundred Eighty-nine Dollars (\$534,789.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Lieutenant Governor by law.

SECTION 47. There is hereby appropriated to the Oklahoma Merit Protection Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Five Hundred Sixty-two Thousand Thirty-eight Dollars (\$562,038.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Merit Protection Commission by law.

SECTION 48. There is hereby appropriated to the Military Department of the State of Oklahoma from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Nine Million Two Hundred Ninety-four Thousand Eight Hundred Thirty-five Dollars (\$9,294,835.00) or so much thereof as may be necessary to perform the duties imposed upon the Military Department of the State of Oklahoma by law.

SECTION 49. There is hereby appropriated to the Office of Personnel Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Four Million Six Hundred Twenty-three Thousand Six Hundred Thirty-three Dollars (\$4,623,633.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Personnel Management by law.

SECTION 50. There is hereby appropriated to the Office of the Secretary of State from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Five Hundred Eight Thousand Six Hundred Seventeen Dollars (\$508,617.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Secretary of State by law.

SECTION 51. There is hereby appropriated to the Oklahoma State Senate from any monies not otherwise appropriated from the Constitutional Reserve Fund of the State Treasury, the following amount, or so much thereof as may be necessary to pay monthly salaries, per diem, and expenses of the members of the Senate and the salaries of its employees, and such contingent expenses as may be ordered paid therefrom, including the preparation and printing of the journals and calendars of the Senate, and including the preparation and printing of the permanent journals thereof, in accordance with the following amount herein set forth:

SECTION 52. There is hereby appropriated to the Oklahoma Space Industry Development Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Five Hundred Twenty-three Thousand Two Hundred Sixty-five Dollars (\$523,265.00) or so much thereof as may be necessary to perform the duties imposed upon the Space Industry Development Authority by law.

SECTION 53. There is hereby appropriated to the Oklahoma Tax Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Forty-two Million Nine Hundred Seventy-five Thousand Seven Hundred Five Dollars (\$42,975,705.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Tax Commission by law.

There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Three Hundred Sixty-four Thousand One Hundred Fourteen Dollars (\$364,114.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 111. There is hereby appropriated to the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Five Million One Hundred Sixty Thousand Five Hundred Eleven Dollars (\$5,160,511.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control by law.

SECTION 112. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Seventy-eight Million Three Hundred Forty-one Thousand Three Hundred Nineteen Dollars (\$78,341,319.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law.

SECTION 113. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the C.L.E.E.T. Fund for the fiscal year ending June 30, 2006, the sum of One Million One Hundred Fifty-eight Thousand Six Hundred Eighty-one Dollars (\$1,158,681.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law.

SECTION 114. There is hereby appropriated to the Oklahoma Indigent Defense System from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Fifteen Million Five Hundred Thousand Dollars (\$15,500,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Indigent Defense System by law.

SECTION 115. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year

ending June 30, 2006, the sum of Six Million Two Hundred Nine Thousand Four Hundred Fifty-nine Dollars (\$6,209,459.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Attorney General by law.

SECTION 116. There is hereby appropriated to the Court of Criminal Appeals from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Two Million Eight Hundred Five Thousand Nine Hundred Eleven Dollars (\$2,805,911.00) or so much thereof as may be necessary to perform the duties imposed upon the Court of Criminal Appeals by law.

SECTION 117. The Supreme Court is hereby authorized to expend during the fiscal year ending June 30, 2006, the sum of Forty-three Million Nine Hundred Thirty-six Thousand Six Hundred Fifty-seven Dollars (\$43,936,657.00) from the State Judicial Revolving Fund to perform the duties imposed upon the district courts by law.

SECTION 118. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Twenty-nine Million Dollars (\$29,000,000.00) or so much thereof as may be necessary to perform the duties imposed upon the District Attorneys Council by law. Of the funds appropriated herein, the Office of the Attorney General shall transfer up to the sum of Five Hundred Fifteen Thousand Three Hundred Seventeen Dollars (\$515,317.00) or so much thereof as may be required by the district attorneys and District Attorneys Council to the District Attorneys Evidence Fund for necessary expenses relative to any case within the official responsibility of the offices of the district attorneys as provided by Section 215.40 of Title 19 of the Oklahoma Statutes.

SECTION 119. For the fiscal year ending June 30, 2006, the District Attorneys Council is authorized to transfer an amount not

to exceed Three Hundred Thousand Dollars (\$300,000.00), on an as-needed basis, from the Crime Victims Compensation Revolving Fund created by Section 142.17 of Title 21 of the Oklahoma Statutes to the Sexual Assault Examination Fund created by Section 142.20 of Title 21 of the Oklahoma Statutes.

SECTION 120. For the fiscal year ending June 30, 2006, up to Four Hundred Seventy-five Thousand Dollars (\$475,000.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes to the District Attorneys Council for eight employees, including related duties to support the Crime Victims Compensation Board.

SECTION 121. For the fiscal year ending June 30, 2006, up to One Million Three Hundred Two Thousand Dollars (\$1,302,000.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes to the District Attorneys Council for duties to support Victim-Witness Services.

SECTION 122. There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Three Million Nine Hundred Forty-five Thousand Five Hundred Eighteen Dollars (\$3,945,518.00) or so much thereof as may be necessary to perform the duties imposed upon the Workers' Compensation Court by law.

SECTION 123. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Nine Million Five Hundred Forty-one Thousand Eight Hundred Ninety-four Dollars (\$9,541,894.00) or so much thereof as may be necessary to perform the duties imposed upon the Supreme Court or Court of Civil Appeals by law.

SECTION 124. The Supreme Court is hereby authorized to expend during the fiscal year ending June 30, 2006, the sum of Two Million Four Hundred One Thousand Two Hundred Seventy-four Dollars (\$2,401,274.00) from the State Judicial Revolving Fund to perform the duties imposed upon the Supreme Court or Court of Civil Appeals by law.

SECTION 125. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Seven Hundred Sixty-four Thousand Eight Hundred Forty-five Dollars (\$764,845.00) to transfer to the Legal Services Revolving Fund created pursuant to subsection G of Section 921.1 of Title 12 of the Oklahoma Statutes.

SECTION 126. There is hereby appropriated to the Supreme Court for deposit in the Supreme Court Revolving Fund from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Nine Hundred Thousand Dollars (\$900,000.00) for expenditures authorized by Section 1310.1 of Title 20 of the Oklahoma Statutes.

SECTION 127. There is hereby appropriated to the Council on Judicial Complaints from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Two Hundred Seventy-five Thousand Three Hundred Twenty-one Dollars (\$275,321.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Judicial Complaints by law.

SECTION 128. There is hereby appropriated to the Department of Human Services, from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Twenty-two Million Nine Hundred Thousand Dollars (\$22,900,000.00) or so much thereof as may be necessary to perform the duties imposed upon the State Department of Health by law.

SECTION 129. There is hereby appropriated to the Department of Corrections from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Ten Million Dollars (\$10,000,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Corrections by law.

SECTION 130. There is hereby appropriated to the Oklahoma Indigent Defense System from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of One Million One Hundred Fifty Thousand Dollars (\$1,150,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Indigent Defense System by law.

SECTION 131. Sections 1 through 127 of this act shall become effective July 1, 2005.
