BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. AMENDATORY 74 O.S. 2001, Section 3903, as
2 amended by Section 1, Chapter 331, O.S.L. 2002 (74 O.S. Supp. 2007,
3 Section 3903), is amended to read as follows:

4 Section 3903. The following statutory entities and their
5 successors shall be terminated on July 1, ~~2008~~ 2012, and all powers,
6 duties and functions shall be abolished one (1) year thereafter:

7 1. Oklahoma State Committee of Plumbing Examiners as created by
8 Section 1004 of Title 59 of the Oklahoma Statutes;

9 2. Waterworks and Wastewater Works Advisory Council as created
10 by Section 1103 of Title 59 of the Oklahoma Statutes;

11 ~~3. Special Agency Account Board as created by Section 7.2 of~~
12 ~~Title 62 of the Oklahoma Statutes;~~

13 ~~4. State Board of Examiners of Certified Shorthand Reporters as~~
14 ~~created by Section 1501 of Title 20 of the Oklahoma Statutes;~~

15 ~~5.~~ 4. Oklahoma EMS Emergency Response Systems Development
16 Advisory Council as created by Section 1-2516 of Title 63 of the
17 Oklahoma Statutes;

18 ~~6. Advisory Council on Alcohol and Drug Abuse as created by~~
19 ~~Section 3-407 of Title 43A of the Oklahoma Statutes; and~~

3 SECTION 2. AMENDATORY 74 O.S. 2001, Section 3917, as
4 amended by Section 3, Chapter 24, O.S.L. 2005 (74 O.S. Supp. 2007,
5 Section 3917), is amended to read as follows:

6 Section 3917. A. Any statutory entity enumerated in the
7 Oklahoma Sunset Law shall, if re-created, be placed in this act to
8 be terminated or re-created not more than ~~six (6)~~ four (4) years
9 thereafter.

10 B. The Oklahoma Department of Libraries shall monitor actions
11 of the State Legislature and maintain a list of all agencies,
12 boards, commissions, committees or other entities created or
13 authorized by law, and all entities created by a Governor's
14 Executive Order. The updated list shall be provided to the
15 Governor, the President Pro Tempore of the Oklahoma Senate, the
16 Speaker of the Oklahoma House of Representatives, and the chairs of
17 the appropriate House or Senate sunset committee within thirty (30)
18 days after sine die adjournment of each legislative session."
