13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY 74 O.S. 2001, Section 3908, as  
15 amended by Section 3, Chapter 208, O.S.L. 2006 (74 O.S. Supp. 2006,  
16 Section 3908), is amended to read as follows:

17 Section 3908. The following statutory entities and their  
18 successors shall be terminated on July 1, ~~2007~~ 2013, and all powers,  
19 duties and functions shall be abolished one (1) year thereafter:
