8 An Act relating to sunset; amending 74 O.S. 2001,
9 Section 3903, as amended by Section 1, Chapter 331,
10 O.S.L. 2002 (74 O.S. Supp. 2007, Section 3903), which
11 relates to the termination of certain statutory
12 entities; re-creating certain entities; modifying
13 list of statutory entities subject to re-creation;
14 and modifying termination date.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 74 O.S. 2001, Section 3903, as
17 amended by Section 1, Chapter 331, O.S.L. 2002 (74 O.S. Supp. 2007,
18 Section 3903), is amended to read as follows:

19 Section 3903. The following statutory entities and their
20 successors shall be terminated on July 1, ~~2008~~ 2012, and all powers,
21 duties and functions shall be abolished one (1) year thereafter:

22 1. Oklahoma State Committee of Plumbing Examiners as created by
23 Section 1004 of Title 59 of the Oklahoma Statutes;

24 2. Waterworks and Wastewater Works Advisory Council as created
by Section 1103 of Title 59 of the Oklahoma Statutes;

2 ~~Title 62 of the Oklahoma Statutes;~~

3 4. State Board of Examiners of Certified Shorthand Reporters as
4 created by Section 1501 of Title 20 of the Oklahoma Statutes;

5 5. 4. Oklahoma EMS Emergency Response Systems Development
6 Advisory Council as created by Section 1-2516 of Title 63 of the
7 Oklahoma Statutes;

8 6. ~~Advisory Council on Alcohol and Drug Abuse as created by~~
9 ~~Section 3-407 of Title 43A of the Oklahoma Statutes; and~~

10 7. 5. Oklahoma Educational Television Authority as created by
11 Section 23-105 of Title 70 of the Oklahoma Statutes;

12 6. State Board of Examiners of Perfusionists as created by
13 Section 2053 of Title 59 of the Oklahoma Statutes; and

14 7. Public Employees Relations Board as created by Section 51-
15 104 of Title 11 of the Oklahoma Statutes.
