8 An Act relating to amusements and sports; amending
9 Section 3, Chapter 336, O.S.L. 2007 (3A O.S. Supp.
10 2007, Section 724.2), which relates to the lottery;
11 expanding certain debt collection option; and
12 providing an effective date.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY Section 3, Chapter 336, O.S.L.
15 2007 (3A O.S. Supp. 2007, Section 724.2), is amended to read as
16 follows:

17 Section 724.2 A. The Oklahoma Lottery Commission shall
18 withhold the amount of delinquent debt as established by the
19 Oklahoma Tax Commission or as established by a state agency or
20 district court seeking to collect a debt or final judgment pursuant
21 to the provisions of Section 205.2 of Title 68 of the Oklahoma
22 Statutes from the lottery prize monies won by an individual pursuant
23 to Section 710 of ~~Title 3A of the Oklahoma Statutes~~ this title.

1 B. The Oklahoma Lottery Commission shall pay the monies
2 withheld from the lottery prize, as provided in subsection A of this
3 section, to the ~~Oklahoma Tax Commission~~ appropriate state entity,
4 not to exceed the amount of debt established by the Oklahoma Tax
5 Commission.

6 C. The Oklahoma Tax Commission shall promulgate rules to define
7 the debts that will be submitted to the Oklahoma Lottery Commission
8 for withholding.

9 D. The Oklahoma Tax Commission shall develop procedures for
10 timely notifying the Oklahoma Lottery Commission of the debts that
11 should be processed for withholding. The information on debt
12 withholding will be reported to the Oklahoma Lottery Commission on a
13 periodic basis and should include, but not be limited to:

14 1. Identification of the persons who have been determined to be
15 delinquent in the repayment of debt established by the Oklahoma Tax
16 Commission; and

17 2. The amounts of debt to be withheld by the Oklahoma Lottery
18 Commission.

19 E. The Oklahoma Lottery Commission shall provide a report to
20 the Oklahoma Tax Commission upon withholding that includes, but is
21 not limited to, the following information:

22 1. Identification of the persons who have had monies withheld;
23 and

1 2. The amount of monies that will be paid to the ~~Oklahoma Tax~~
2 ~~Commission~~ appropriate state entity to be applied to the established
3 debt.

4 SECTION 2. This act shall become effective November 1, 2008.
