10 An Act relating to sunset; amending 74 O.S. 2001,
11 Sections 3903, as amended by Section 1, Chapter 331,
12 O.S.L. 2002, and 3908, as amended by Section 3,
13 Chapter 208, O.S.L. 2006 (74 O.S. Supp. 2006,
14 Sections 3903 and 3908), which relate to re-creating
15 certain entities; and modifying termination date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 74 O.S. 2001, Section 3903, as
18 amended by Section 1, Chapter 331, O.S.L. 2002 (74 O.S. Supp. 2006,
19 Section 3903), is amended to read as follows:

20 Section 3903. The following statutory entities and their
21 successors shall be terminated on July 1, 2008, and all powers,
22 duties and functions shall be abolished one (1) year thereafter:

24 Section 1004 of Title 59 of the Oklahoma Statutes;

6 created by Section 1501 of Title 20 of the Oklahoma Statutes;
- 7 5. Oklahoma EMS Advisory Council as created by Section 1-2516
8 of Title 63 of the Oklahoma Statutes;
- 9 6. Advisory Council on Alcohol and Drug Abuse as created by
10 Section 3-407 of Title 43A of the Oklahoma Statutes; ~~and~~
- 11 7. Oklahoma Educational Television Authority as created by
12 Section 23-105 of Title 70 of the Oklahoma Statutes; and
- 13 8. Public Employees Relations Board as created by Section 51-
14 104 of Title 11 of the Oklahoma Statutes.
