10 CONFERENCE COMMITTEE SUBSTITUTE

11 An Act relating to Oklahoma Department of Commerce;  
12 directing certain transfer; exempting transfer from  
13 certain agency category or budget limits; requiring  
14 and authorizing the expenditure of certain funds for  
15 certain purposes; exempting certain contracts from  
16 the Oklahoma Central Purchasing Act; and declaring an  
17 emergency.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. TRANSFER The Director of State Finance shall  
20 transfer the sum of Ten Million Dollars (\$10,000,000.00) from the  
21 Unclaimed Property Fund established pursuant to Section 668 of Title  
22 60 of the Oklahoma Statutes to the 205 Fund of the Oklahoma  
23 Department of Commerce. The transfer authorized by this section  
24 shall not be subject to fiscal year 2009 agency category or budget  
limits.

1           SECTION 2. The Oklahoma Department of Commerce shall expend  
2 the sum of Six Million Dollars (\$6,000,000.00) from the amount  
3 transferred in Section 1 of this act to accomplish contractual  
4 responsibilities with the Association of Central Oklahoma  
5 Governments to facilitate acquiring the former General Motors  
6 Oklahoma City Assembly Plant. Funds expended for this purpose shall  
7 be exempt from the requirements of the Oklahoma Central Purchasing  
8 Act. The Oklahoma Department of Commerce shall expend the sum of One  
9 Million Dollars (\$1,000,000.00) from the amount transferred in  
10 Section 1 of this act to accomplish contractual responsibilities  
11 with the South Western Oklahoma Development Authority for the  
12 purpose of facilitating the purchase of a hangar at the Quartz  
13 Mountain Regional Airport from the City of Altus to be used as an  
14 aviation and technology classroom for the Southwest Technology  
15 Center. Funds expended for this purpose shall be exempt from the  
16 requirements of the Oklahoma Central Purchasing Act. The Oklahoma  
17 Department of Commerce shall expend the sum of Five Hundred Thousand  
18 Dollars (\$500,000.00) from the amount transferred in Section 1 of  
19 this act to accomplish contractual responsibilities with the  
20 Association of South Central Oklahoma Governments for the purpose of  
21 reimbursing Comanche County Industrial Development Authority for a  
22 contract with Delta Air Lines, Inc. Funds expended for this purpose  
23 shall be exempt from the requirements of the Oklahoma Central  
24 Purchasing Act. The Oklahoma Department of Commerce shall expend

1 the sum of Two Million Five Hundred Thousand Dollars (\$2,500,000.00)  
2 from the amount transferred in Section 1 of this act to accomplish  
3 contractual responsibilities with the Southern Oklahoma Development  
4 Association for the Biodiesel Fuel Center. Funds expended for this  
5 purpose shall be exempt from the requirements of the Oklahoma  
6 Central Purchasing Act.

7 SECTION 3. It being immediately necessary for the preservation  
8 of the public peace, health and safety, an emergency is hereby  
9 declared to exist, by reason whereof this act shall take effect and  
10 be in full force from and after its passage and approval.
