10 CONFERENCE COMMITTEE SUBSTITUTE

11 An Act relating to the Oklahoma Health Care  
12 Authority; amending Sections 71 and 74 of Enrolled  
13 House Bill No. 2276 of the 2nd Session of the 51st  
14 Oklahoma Legislature, which relate to appropriations  
15 to the Oklahoma Health Care Authority; modifying  
16 appropriation amounts; providing an effective date;  
17 and declaring an emergency.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. AMENDATORY Section 71 of Enrolled House Bill  
20 No. 2276 of the 2nd Session of the 51st Oklahoma Legislature, is  
21 amended to read as follows:

22 Section 71. There is hereby appropriated to the Oklahoma Health  
23 Care Authority from any monies not otherwise appropriated from the  
24 General Revenue Fund of the State Treasury for the fiscal year  
ending June 30, 2009, the sum of ~~Seven Hundred Eleven Million Four~~

1 ~~Hundred Seventy two Thousand Two Hundred Sixty one Dollars~~  
2 ~~(\$711,472,261.00)~~ Seven Hundred One Million Four Hundred Seventy-two  
3 Thousand Two Hundred Sixty-one Dollars (\$701,472,261.00) or so much  
4 thereof as may be necessary to perform the duties imposed upon the  
5 Oklahoma Health Care Authority by law.

6 SECTION 2. AMENDATORY Section 74 of Enrolled House Bill  
7 No. 2276 of the 2nd Session of the 51st Oklahoma Legislature, is  
8 amended to read as follows:

9 Section 74. There is hereby appropriated to the Oklahoma Health  
10 Care Authority from any monies not otherwise appropriated from the  
11 Tobacco Settlement Fund of the State, the sum of ~~Fourteen Million~~  
12 ~~One Hundred Fifty Thousand Dollars (\$14,150,000.00)~~ Twenty-four  
13 Million One Hundred Fifty Thousand Dollars (\$24,150,000.00) or so  
14 much thereof as may be necessary to perform the duties imposed upon  
15 the Health Care Authority by law.

16 SECTION 3. This act shall become effective July 1, 2008.

17 SECTION 4. It being immediately necessary for the preservation  
18 of the public peace, health and safety, an emergency is hereby  
19 declared to exist, by reason whereof this act shall take effect and  
20 be in full force from and after its passage and approval.
