11 An Act relating to general appropriations for the
12 expenses of various agencies of the executive,
13 legislative and judicial departments of the state;
14 making appropriations to the Oklahoma Arts Council,
15 the State Board of Education, the Oklahoma
16 Educational Television Authority, the Oklahoma State
17 Regents for Higher Education, the Oklahoma Department
18 of Libraries, the Commissioners of the Land Office,
19 the Physician Manpower Training Commission, the Board
20 of Trustees of the Oklahoma School of Science and
21 Mathematics, the Oklahoma Center for the Advancement
22 of Science and Technology, the Oklahoma Commission

6 and Youth, the Office of Handicapped Concerns, the
7 Oklahoma Human Rights Commission, the Department of
8 Human Services, the State Department of
9 Rehabilitation Services, the Oklahoma Indian Affairs
10 Commission, the Office of Juvenile Affairs, the
11 Department of Mental Health and Substance Abuse
12 Services, the State Department of Health, the
13 University Hospitals Authority, the Oklahoma Health
14 Care Authority, the J.D. McCarty Center for Children
15 with Developmental Disabilities, the Oklahoma
16 Department of Veterans Affairs, the Oklahoma
17 Department of Agriculture, Food, and Forestry, the
18 Oklahoma Capitol Complex and Centennial Commemoration
19 Commission, the Oklahoma Department of Commerce, the
20 Oklahoma Conservation Commission, the Department of
21 Consumer Credit, the Corporation Commission, the
22 Department of Environmental Quality, the Oklahoma
23 Historical Society, the Oklahoma Horse Racing
24 Commission, the Insurance Department, the J.M. Davis
Memorial Commission, the Department of Labor, the
Department of Mines, the Scenic Rivers Commission,
the Oklahoma Tourism and Recreation Department, the
Oklahoma Water Resources Board, the Will Rogers
Memorial Commission, the Alcoholic Beverage Laws
Enforcement Commission, the Department of
Corrections, the Office of the State Fire Marshal,
the Oklahoma State Bureau of Investigation, the
Council on Law Enforcement Education and Training,
the Board of Medicolegal Investigations, the Oklahoma
State Bureau of Narcotics and Dangerous Drugs
Control, the Pardon and Parole Board, the Department
of Public Safety, the Office of the Attorney General,
district attorneys and the District Attorneys
Council, the Court of Criminal Appeals, the Supreme
Court, the Council on Judicial Complaints, the
Workers' Compensation Court, and the Oklahoma
Indigent Defense System; stating sums of the
appropriations; stating purposes and restrictions;
authorizing and requiring certain expenditures;
requiring transfer of certain funds; and providing an
effective date.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 SUBCOMMITTEE ON EDUCATION

3 SECTION 1. There is hereby appropriated to the Oklahoma Arts
4 Council from any monies not otherwise appropriated from the General
5 Revenue Fund of the State Treasury for the fiscal year ending June
6 30, 2008, the sum of Five Million One Hundred Fifty Thousand Nine
7 Hundred Sixty-seven Dollars (\$5,150,967.00) or so much thereof as
8 may be necessary to perform the duties imposed upon the Oklahoma
9 Arts Council by law.

10 SECTION 2. There is hereby appropriated to the State Board of
11 Education from any monies not otherwise appropriated from the
12 General Revenue Fund of the State Treasury for the fiscal year
13 ending June 30, 2008, the sum of One Billion Two Hundred Forty-seven
14 Million Three Hundred Thirty-two Thousand One Hundred Forty-two
15 Dollars (\$1,247,332,142.00) or so much thereof as may be necessary
16 for the financial support of public schools.

17 SECTION 3. There is hereby appropriated to the State Board of
18 Education from any monies not otherwise appropriated from the
19 Education Reform Revolving Fund created in Section 41.29b of Title
20 62 of the Oklahoma Statutes, the sum of Six Hundred Forty-eight
21 Million Two Hundred Twenty-four Thousand Two Hundred Twenty-three
22 Dollars (\$648,224,223.00) or so much thereof as may be necessary for
23 the financial support of public schools.

1 SECTION 4. The State Board of Education is hereby authorized to
2 expend during the fiscal year ending June 30, 2008, from the Common
3 Education Technology Revolving Fund of the State Treasury, the sum
4 of Fifty Million Three Hundred Seventy-four Thousand Two Hundred
5 Eighty-four Dollars (\$50,374,284.00) or so much thereof as may be
6 necessary for the financial support of public schools.

7 SECTION 5. There is hereby appropriated to the State Board of
8 Education, from any monies not otherwise appropriated from the
9 Mineral Leasing Fund of the State Treasury for the fiscal year
10 ending June 30, 2008, the sum of Four Million Five Hundred Sixty
11 Thousand Dollars (\$4,560,000.00) or so much thereof as may be
12 necessary for the financial support of public schools.

13 SECTION 6. There is hereby appropriated to the State Board of
14 Education, from any monies not otherwise appropriated from the
15 Mineral Leasing Fund of the State Treasury for the fiscal year
16 ending June 30, 2006, the sum of Two Million Two Hundred Twenty-six
17 Thousand Nine Hundred Eighty-one Dollars (\$2,226,981.00) or so much
18 thereof as may be necessary for the financial support of public
19 schools.

20 SECTION 7. There is hereby appropriated to the State Board of
21 Education from the Oklahoma Education Lottery Trust Fund of the
22 State Treasury for the fiscal year ending June 30, 2008, the sum of
23 Thirty-six Million Eight Hundred Sixty-one Thousand Nine Hundred
24

1 Eighty-four Dollars (\$36,861,984.00) or so much thereof as may be
2 necessary for the financial support of public schools.

3 SECTION 8. There is hereby appropriated to the State Board of
4 Education from the Oklahoma Education Lottery Trust Fund of the
5 State Treasury for the fiscal year ending June 30, 2006, the sum of
6 Three Million Four Thousand Eight Hundred Ninety-three Dollars
7 (\$3,004,893.00) or so much thereof as may be necessary for the
8 financial support of public schools.

9 SECTION 9. There is hereby appropriated to the State Board of
10 Education from any monies not otherwise appropriated from the
11 General Revenue Fund of the State Treasury for the fiscal year
12 ending June 30, 2008, the sum of Four Hundred Fifteen Million Four
13 Hundred Eighty-four Thousand One Hundred Thirty-seven Dollars
14 (\$415,484,137.00) or so much thereof as may be necessary for the
15 support of public school activities.

16 SECTION 10. There is hereby appropriated to the State Board of
17 Education from any monies not otherwise appropriated from the
18 Special Cash Fund of the State Treasury the sum of Thirty-three
19 Million Dollars (\$33,000,000.00) or so much thereof as may be
20 necessary for the purchase of textbooks.

21 SECTION 11. There is hereby appropriated to the State Board of
22 Education from any monies not otherwise appropriated from the
23 General Revenue Fund of the State Treasury for the fiscal year
24 ending June 30, 2007, the sum of Five Million Nine Hundred Seventy-

1 one Thousand Seven Hundred Fifteen Dollars (\$5,971,715.00) or so
2 much thereof as may be necessary for the purpose of funding
3 Education Leadership Oklahoma.

4 SECTION 12. There is hereby appropriated to the State Board of
5 Education from any monies not otherwise appropriated from the
6 General Revenue Fund of the State Treasury for the fiscal year
7 ending June 30, 2008, the sum of Twenty-four Million Two Hundred
8 Fifty-five Thousand Five Hundred Forty-two Dollars (\$24,255,542.00)
9 or so much thereof as may be necessary for administrative and
10 support functions of the State Department of Education.

11 SECTION 13. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 Oklahoma Education Lottery Trust Fund of the State Treasury for the
14 fiscal year ending June 30, 2008, the sum of Four Million Ninety-
15 five Thousand Seven Hundred Seventy-six Dollars (\$4,095,776.00) or
16 so much thereof as may be necessary for transfer to the School
17 Consolidation Assistance Fund.

18 SECTION 14. There is hereby appropriated to the State Board of
19 Education from any monies not otherwise appropriated from the
20 Oklahoma Education Lottery Trust Fund of the State Treasury for the
21 fiscal year ending June 30, 2006, the sum of Three Hundred Thirty-
22 three Thousand Eight Hundred Seventy-seven Dollars (\$333,877.00) or
23 so much thereof as may be necessary for transfer to the School
24 Consolidation Assistance Fund.

1 SECTION 15. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 Oklahoma Education Lottery Trust Fund of the State Treasury for the
4 fiscal year ending June 30, 2008, the sum of Four Million Ninety-
5 five Thousand Seven Hundred Seventy-six Dollars (\$4,095,776.00) or
6 so much thereof as may be necessary for transfer to the Teachers'
7 Retirement System Dedicated Revenue Revolving Fund.

8 SECTION 16. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the
11 fiscal year ending June 30, 2006, the sum of Three Hundred Thirty-
12 three Thousand Eight Hundred Seventy-seven Dollars (\$333,877.00) or
13 so much thereof as may be necessary for transfer to the Teachers'
14 Retirement System Dedicated Revenue Revolving Fund.

15 SECTION 17. There is hereby appropriated to the Oklahoma
16 Educational Television Authority from any monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury for
18 the fiscal year ending June 30, 2008, the sum of Eight Million Three
19 Hundred Ninety-four Thousand Three Hundred Eighty-three Dollars
20 (\$8,394,383.00) or so much thereof as may be necessary to perform
21 the duties imposed upon the Oklahoma Educational Television
22 Authority by law.

23 SECTION 18. There is hereby appropriated to the Oklahoma State
24 Regents for Higher Education from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury for
2 the fiscal year ending June 30, 2008, the sum of Eight Hundred
3 Fifty-two Million Six Hundred Sixteen Thousand Three Hundred Forty-
4 one Dollars (\$852,616,341.00) or so much thereof as may be necessary
5 for allocation by the Oklahoma State Regents for Higher Education
6 pursuant to the provisions of Article XIII-A of the Oklahoma
7 Constitution for the education and general operating budgets of the
8 institutions and for other programs, construction, renovations or
9 repairs administered by the Oklahoma State Regents for Higher
10 Education. Of those funds appropriated, the sum of Four Million
11 Three Hundred Forty-four Thousand Six Hundred Fifty Dollars
12 (\$4,344,650.00) shall be transferred to the Oklahoma Tuition
13 Equalization Grant Trust Fund to implement the provisions of the
14 Oklahoma Tuition Equalization Grant Act.

15 SECTION 19. The Oklahoma State Regents for Higher Education are
16 hereby authorized to expend during the fiscal year ending June 30,
17 2008, the sum of Fifty Million Three Hundred Seventy-four Thousand
18 Two Hundred Eighty-four Dollars (\$50,374,284.00) from the Higher
19 Education Capital Revolving Fund of the State Treasury for
20 allocation by the Oklahoma State Regents for Higher Education
21 pursuant to the provisions of Article XIII-A of the Oklahoma
22 Constitution for the education and general operating budgets of the
23 institutions and for other programs, construction, renovations or

1 repairs administered by the Oklahoma State Regents for Higher
2 Education.

3 SECTION 20. The Oklahoma State Regents for Higher Education are
4 hereby authorized to expend during the fiscal year ending June 30,
5 2008, the sum of Fifty Million Three Hundred Seventy-four Thousand
6 Two Hundred Eighty-four Dollars (\$50,374,284.00) from the Oklahoma
7 Student Aid Revolving Fund of the State Treasury for allocation by
8 the Oklahoma State Regents for Higher Education pursuant to the
9 provisions of Article XIII-A of the Oklahoma Constitution for the
10 education and general operating budgets of the institutions and for
11 other programs, construction, renovations or repairs administered by
12 the Oklahoma State Regents for Higher Education.

13 SECTION 21. There is hereby appropriated to the Oklahoma State
14 Regents for Higher Education from any monies not otherwise
15 appropriated from the Special Cash Fund of the State Treasury the
16 sum of Nine Million Four Hundred One Thousand Four Hundred Six
17 Dollars (\$9,401,406.00) for allocation by the Oklahoma State Regents
18 for Higher Education pursuant to the provisions of Article XIII-A of
19 the Oklahoma Constitution for the education and general operating
20 budgets of the institutions and for other programs, construction,
21 renovations or repairs administered by the Oklahoma State Regents
22 for Higher Education.

23 SECTION 22. The Oklahoma State Regents for Higher Education are
24 hereby authorized to expend during the fiscal year ending June 30,

1 2008, the sum of Ten Million Seven Hundred Fifty Thousand Two
2 Hundred Thirty-eight Dollars (\$10,750,238.00) from the Oklahoma
3 Higher Learning Access Trust Fund of the State Treasury or so much
4 thereof as may be necessary for expenditures in the Oklahoma Higher
5 Learning Access Program.

6 SECTION 23. There is hereby appropriated to the Oklahoma State
7 Regents for Higher Education from any monies not otherwise
8 appropriated from the Special Cash Fund of the State Treasury the
9 sum of Thirty-seven Million Three Hundred Fifty-four Thousand Seven
10 Hundred Sixty-two Dollars (\$37,354,762.00) or so much thereof as may
11 be necessary for expenditures in the Oklahoma Higher Learning Access
12 Program.

13 SECTION 24. There is hereby appropriated to the Oklahoma State
14 Regents for Higher Education from any monies not otherwise
15 appropriated from the General Revenue Fund of the State Treasury for
16 the fiscal year ending June 30, 2008, the sum of One Million Four
17 Hundred Thousand Dollars (\$1,400,000.00) or so much thereof as may
18 be necessary for expenditures for concurrent enrollment pursuant to
19 Section 628.13 of Title 70 of the Oklahoma Statutes.

20 SECTION 25. There is hereby appropriated to the Oklahoma State
21 Regents for Higher Education from any monies not otherwise
22 appropriated from the Oklahoma Education Lottery Trust Fund of the
23 State Treasury for the fiscal year ending June 30, 2008, the sum of
24 Thirty-two Million Three Hundred Sixty-one Thousand Nine Hundred

1 Eighty-three Dollars (\$32,361,983.00) pursuant to paragraph 2 of
2 subsection C of Section 713 of Title 3A of the Oklahoma Statutes for
3 allocation by the Oklahoma State Regents for Higher Education
4 pursuant to the provisions of Article XIII-A of the Oklahoma
5 Constitution for construction, renovations or repairs administered
6 by the Oklahoma State Regents for Higher Education or for any other
7 purpose authorized by paragraph 2 of subsection C of Section 713 of
8 Title 3A of the Oklahoma Statutes.

9 SECTION 26. There is hereby appropriated to the Oklahoma State
10 Regents for Higher Education from any monies not otherwise
11 appropriated from the Oklahoma Education Lottery Trust Fund of the
12 State Treasury for the fiscal year ending June 30, 2006, the sum of
13 Three Million Four Thousand Eight Hundred Ninety-two Dollars
14 (\$3,004,892.00) pursuant to paragraph 2 of subsection C of Section
15 713 of Title 3A of the Oklahoma Statutes for allocation by the
16 Oklahoma State Regents for Higher Education pursuant to the
17 provisions of Article XIII-A of the Oklahoma Constitution for
18 construction, renovations or repairs administered by the Oklahoma
19 State Regents for Higher Education or for any other purpose
20 authorized by paragraph 2 of subsection C of Section 713 of Title 3A
21 of the Oklahoma Statutes.

22 SECTION 27. There is hereby appropriated to the Oklahoma State
23 Regents for Higher Education from any monies not otherwise
24 appropriated from the General Revenue Fund of the State Treasury for

1 the fiscal year ending June 30, 2008, the sum of Five Million Five
2 Hundred Sixty-one Thousand Two Hundred Sixty-six Dollars
3 (\$5,561,266.00) or so much thereof as may be necessary for the
4 general operating budget of the Administrative Offices of the
5 Oklahoma State Regents for Higher Education.

6 SECTION 28. There is hereby appropriated to the Oklahoma State
7 Regents for Higher Education from any monies not otherwise
8 appropriated from the General Revenue Fund of the State Treasury for
9 the fiscal year ending June 30, 2008, the sum of Seven Hundred Fifty
10 Thousand One Hundred Twenty Dollars (\$750,120.00) or so much thereof
11 as may be necessary for the Office of Accountability to perform the
12 duties imposed upon the Office of Accountability by law.

13 SECTION 29. There is hereby appropriated to the Oklahoma
14 Department of Libraries from any monies not otherwise appropriated
15 from the General Revenue Fund of the State Treasury for the fiscal
16 year ending June 30, 2008, the sum of Seven Million Two Hundred
17 Ninety-four Thousand Eight Hundred Fifty-six Dollars (\$7,294,856.00)
18 or so much thereof as may be necessary to perform the duties imposed
19 upon the Oklahoma Department of Libraries by law.

20 SECTION 30. There is hereby appropriated to the Commissioners
21 of the Land Office from any monies not otherwise appropriated from
22 the Commissioners of the Land Office Fund of the State Treasury for
23 the fiscal year ending June 30, 2008, the sum of Four Million Eight
24 Hundred Sixty-four Thousand Eight Hundred Eighty-one Dollars

1 (\$4,864,881.00) or so much thereof as may be necessary to perform
2 the duties imposed upon the Commissioners of the Land Office by law.

3 SECTION 31. There is hereby appropriated to the Physician
4 Manpower Training Commission from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2008, the sum of Five Million One
7 Hundred Twenty-three Thousand Five Hundred Two Dollars

8 (\$5,123,502.00) or so much thereof as may be necessary to perform
9 the duties imposed upon the Physician Manpower Training Commission
10 by law.

11 SECTION 32. There is hereby appropriated to the Physician
12 Manpower Training Commission from any monies not otherwise
13 appropriated from the Special Cash Fund of the State Treasury, the
14 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much
15 thereof as may be necessary to perform the duties imposed upon the
16 Physician Manpower Training Commission by law.

17 SECTION 33. There is hereby appropriated to the Board of
18 Trustees of the Oklahoma School of Science and Mathematics from any
19 monies not otherwise appropriated from the General Revenue Fund of
20 the State Treasury for the fiscal year ending June 30, 2008, the sum
21 of Seven Million Five Hundred Eighty-five Thousand Seven Hundred
22 Thirty-two Dollars (\$7,585,732.00) or so much thereof as may be
23 necessary to perform the duties imposed upon the Board of Trustees
24 of the Oklahoma School of Science and Mathematics by law.

1 SECTION 34. There is hereby appropriated to the Oklahoma Center
2 for the Advancement of Science and Technology from any monies not
3 otherwise appropriated from the General Revenue Fund of the State
4 Treasury for the fiscal year ending June 30, 2008, the sum of
5 Twenty-two Million Four Hundred Fifty-six Thousand Five Hundred
6 Seven Dollars (\$22,456,507.00) or so much thereof as may be
7 necessary to perform the duties imposed upon the Oklahoma Center for
8 the Advancement of Science and Technology by law.

9 SECTION 35. There is hereby appropriated to the Oklahoma
10 Commission for Teacher Preparation from any monies not otherwise
11 appropriated from the General Revenue Fund of the State Treasury for
12 the fiscal year ending June 30, 2008, the sum of Two Million Fifty-
13 nine Thousand Nine Hundred Eighty-two Dollars (\$2,059,982.00) or so
14 much thereof as may be necessary to perform the duties imposed upon
15 the Oklahoma Commission for Teacher Preparation by law.

16 SECTION 36. There is hereby appropriated to the State Board of
17 Career and Technology Education from any monies not otherwise
18 appropriated from the General Revenue Fund of the State Treasury for
19 the fiscal year ending June 30, 2008, the sum of One Hundred Fifty
20 Million Three Hundred Sixty-four Thousand Three Hundred Ninety-one
21 Dollars (\$150,364,391.00) or so much thereof as may be necessary to
22 perform the duties imposed upon the State Board of Career and
23 Technology Education by law.

24

1 SECTION 37. There is hereby appropriated to the State Board of
2 Career and Technology Education from any monies not otherwise
3 appropriated from the Oklahoma Education Lottery Trust Fund of the
4 State Treasury for the fiscal year ending June 30, 2008, the sum of
5 Four Million Five Hundred Thousand Dollars (\$4,500,000.00) pursuant
6 to paragraph 2 of subsection C of Section 713 of Title 3A of the
7 Oklahoma Statutes for allocation by the State Board of Career and
8 Technology Education for the education and general operating budgets
9 of the institutions and for other programs, construction,
10 renovations or repairs administered by the State Board of Career and
11 Technology Education.

12 SECTION 38. The Oklahoma Board of Private Vocational Schools is
13 hereby authorized to expend during the fiscal year ending June 30,
14 2008, from the Oklahoma Board of Private Vocational Schools
15 Revolving Fund of the State Treasury, the sum of One Hundred Ninety-
16 three Thousand Three Hundred Four Dollars (\$193,304.00) or so much
17 thereof as may be necessary to perform the duties imposed upon the
18 Board of Private Vocational Schools by law.

19 SUBCOMMITTEE ON GENERAL GOVERNMENT AND TRANSPORTATION

20 SECTION 39. There is hereby appropriated to the Office of the
21 State Auditor and Inspector from any monies not otherwise
22 appropriated from the General Revenue Fund of the State Treasury for
23 the fiscal year ending June 30, 2008, the sum of Five Million Nine
24 Hundred Fifteen Thousand Two Hundred Sixty-nine Dollars

1 (\$5,915,269.00) or so much thereof as may be necessary to perform
2 the duties imposed upon the Office of the State Auditor and
3 Inspector by law.

4 SECTION 40. There is hereby appropriated to the Office of the
5 State Auditor and Inspector from any monies not otherwise
6 appropriated from the General Revenue Fund of the State Treasury for
7 the fiscal year ending June 30, 2008, the sum of Four Hundred
8 Thousand Dollars (\$400,000.00) or so much thereof as may be
9 necessary to perform the duties imposed upon the Commission on
10 County Government Personnel Education and Training. The
11 appropriation made in this section shall be expended exclusively for
12 the purpose so stated and shall not be transferable.

13 SECTION 41. There is hereby appropriated to the Rural Economic
14 Action Plan Fund of the State Treasury from any monies not otherwise
15 appropriated from the General Revenue Fund of the State Treasury for
16 the fiscal year ending June 30, 2008, the sum of Fifteen Million
17 Five Hundred Thousand Dollars (\$15,500,000.00) or so much thereof as
18 may be necessary to implement the provisions of Sections 2006
19 through 2013 of Title 62 of the Oklahoma Statutes.

20 SECTION 42. There is hereby appropriated to the Office of the
21 State Bond Advisor from any monies not otherwise appropriated from
22 the General Revenue Fund of the State Treasury for the fiscal year
23 ending June 30, 2008, the sum of One Hundred Eighty-six Thousand
24 Four Hundred Nineteen Dollars (\$186,419.00) or so much thereof as

1 may be necessary to perform the duties imposed upon the Office of
2 the State Bond Advisor by law.
