8 An Act relating to motor vehicle insurance; amending
9 36 O.S. 2001, Section 3636, as amended by Section 25,
Chapter 519, O.S.L. 2004 (36 O.S. Supp. 2006, Section
10 3636), which relates to uninsured motorist coverage;
11 providing that forms rejecting or selecting lower
limits remain valid when modifications or changes in
12 policy status occur; providing that completion of new
forms is not required upon the happening of certain
13 circumstances; providing that certain modifications
or changes in status of policy do not create new
14 coverage; modifying prescribed form; limiting
recovery for damages or claims against insurer for
15 liability for motor vehicle accidents in certain
circumstances; providing exceptions; providing who
16 may assert limitation; repealing 47 O.S. 2001,
Section 7-608, as amended by Section 7, Chapter 322,
17 O.S.L. 2006 (47 O.S. Supp. 2006, Section 7-608),
which relates to certain notice requirements;
18 providing for codification; and providing an
effective date.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. AMENDATORY 36 O.S. 2001, Section 3636, as
22 amended by Section 25, Chapter 519, O.S.L. 2004 (36 O.S. Supp. 2006,
23 Section 3636), is amended to read as follows:
24

1 Section 3636. A. No policy insuring against loss resulting
2 from liability imposed by law for bodily injury or death suffered by
3 any person arising out of the ownership, maintenance or use of a
4 motor vehicle shall be issued, delivered, renewed, or extended in
5 this state with respect to a motor vehicle registered or principally
6 garaged in this state unless the policy includes the coverage
7 described in subsection B of this section.

8 B. The policy referred to in subsection A of this section shall
9 provide coverage therein or supplemental thereto for the protection
10 of persons insured thereunder who are legally entitled to recover
11 damages from owners or operators of uninsured motor vehicles and
12 hit-and-run motor vehicles because of bodily injury, sickness or
13 disease, including death resulting therefrom. Coverage shall be not
14 less than the amounts or limits prescribed for bodily injury or
15 death for a policy meeting the requirements of Section 7-204 of
16 Title 47 of the Oklahoma Statutes, as the same may be hereafter
17 amended; provided, however, that increased limits of liability shall
18 be offered and purchased if desired, not to exceed the limits
19 provided in the policy of bodily injury liability of the insured.
20 The uninsured motorist coverage shall be upon a form approved by the
21 Insurance Commissioner as otherwise provided in the Insurance Code
22 and may provide that the parties to the contract shall, upon demand
23 of either, submit their differences to arbitration; provided, that

1 if agreement by arbitration is not reached within three (3) months
2 from date of demand, the insured may sue the tortfeasor.

3 C. For the purposes of this coverage the term "uninsured motor
4 vehicle" shall include an insured motor vehicle where the liability
5 insurer thereof is unable to make payment with respect to the legal
6 liability of its insured within the limits specified therein because
7 of insolvency. For the purposes of this coverage the term
8 "uninsured motor vehicle" shall also include an insured motor
9 vehicle, the liability limits of which are less than the amount of
10 the claim of the person or persons making such claim, regardless of
11 the amount of coverage of either of the parties in relation to each
12 other.

13 D. An insurer's insolvency protection shall be applicable only
14 to accidents occurring during a policy period in which its insured's
15 uninsured motorist coverage is in effect where the liability insurer
16 of the tortfeasor becomes insolvent within one (1) year after such
17 an accident. Nothing herein contained shall be construed to prevent
18 any insurer from according insolvency protection under terms and
19 conditions more favorable to its insured than is provided hereunder.

20 E. For purposes of this section, there is no coverage for any
21 insured while occupying a motor vehicle owned by, or furnished or
22 available for the regular use of the named insured, a resident
23 spouse of the named insured, or a resident relative of the named
24

1 insured, if such motor vehicle is not insured by a motor vehicle
2 insurance policy.

3 F. In the event of payment to any person under the coverage
4 required by this section and subject to the terms and conditions of
5 such coverage, the insurer making such payment shall, to the extent
6 thereof, be entitled to the proceeds of any settlement or judgment
7 resulting from the exercise of any rights of recovery of such person
8 against any person or organization legally responsible for the
9 bodily injury for which such payment is made, including the proceeds
10 recoverable from the assets of the insolvent insurer. Provided,
11 however, with respect to payments made by reason of the coverage
12 described in subsection C of this section, the insurer making such
13 payment shall not be entitled to any right of recovery against such
14 tortfeasor in excess of the proceeds recovered from the assets of
15 the insolvent insurer of said tortfeasor. Provided further, that
16 any payment made by the insured tortfeasor shall not reduce or be a
17 credit against the total liability limits as provided in the
18 insured's own uninsured motorist coverage. Provided further, that
19 if a tentative agreement to settle for liability limits has been
20 reached with an insured tortfeasor, written notice shall be given by
21 certified mail to the uninsured motorist coverage insurer by its
22 insured. Such written notice shall include:

23 1. Written documentation of pecuniary losses incurred,
24 including copies of all medical bills; and

1 2. Written authorization or a court order to obtain reports
2 from all employers and medical providers. Within sixty (60) days of
3 receipt of this written notice, the uninsured motorist coverage
4 insurer may substitute its payment to the insured for the tentative
5 settlement amount. The uninsured motorist coverage insurer shall
6 then be entitled to the insured's right of recovery to the extent of
7 such payment and any settlement under the uninsured motorist
8 coverage. If the uninsured motorist coverage insurer fails to pay
9 the insured the amount of the tentative tort settlement within sixty
10 (60) days, the uninsured motorist coverage insurer has no right to
11 the proceeds of any settlement or judgment, as provided herein, for
12 any amount paid under the uninsured motorist coverage.

13 G. A named insured or applicant shall have the right to reject
14 uninsured motorist coverage in writing, ~~and except that unless a~~
15 ~~named insured or applicant requests such coverage in writing, such~~
16 ~~coverage need not be provided in or supplemental to any renewal,~~
17 ~~reinstatement, substitute, amended or replacement policy where a~~
18 ~~named insured or applicant had rejected the coverage in connection~~
19 ~~with a policy previously issued to him by the same insurer.~~

20 H. ~~Notwithstanding the provisions of this section, the~~
21 ~~following are the only instances in which a new form affecting~~
22 ~~uninsured motorist coverage shall be required:~~

23 1. ~~When an insurer is notified of a change in or an additional~~
24 ~~named insured;~~

1 ~~2. When there is an additional vehicle that is not a~~
2 ~~replacement vehicle; provided, a new form shall not be required for~~
3 ~~the addition, substitution or deletion of a vehicle from a~~
4 ~~commercial automobile liability policy; or~~

5 ~~3. When the amount of bodily injury liability coverage is~~
6 ~~amended. Provided, any change in premium alone shall not require~~
7 ~~the issuance~~ The form signed by the insured or applicant which
8 initially rejects coverage or selects lower limits shall remain
9 valid for the life of the policy and the completion of a new
10 selection form shall not be required when a renewal, reinstatement,
11 substitute, replacement, or amended policy is issued to the same
12 named insured by the same insurer or any of its affiliates. Any
13 changes to an existing policy, regardless of whether these changes
14 create new coverage, do not create a new policy and do not require
15 the completion of a new form.

16 After selection of limits, rejection, or exercise of the option
17 not to purchase uninsured motorist coverage by a named insured or
18 applicant for insurance, the insurer shall not be required to notify
19 any insured in any renewal, reinstatement, substitute, amended or
20 replacement policy as to the availability of such uninsured motorist
21 coverage or such optional limits. Such selection, rejection, or
22 exercise of the option not to purchase uninsured motorist coverage
23 by a named insured or an applicant shall be valid for all insureds
24 under the policy and shall continue until a named insured requests

1 in writing that the uninsured motorist coverage be added to an
2 existing or future policy of insurance.

3 ~~I~~. H. Effective for forms required before April 1, 2005, the
4 offer of the coverage required by subsection B of this section shall
5 be in the following form which shall be filed with and approved by
6 the Insurance Commissioner. The form shall be provided to the
7 proposed insured in writing separately from the application and
8 shall read substantially as follows:

1 change of their Uninsured Motorist coverage limits and that notice
2 shall state how such policyholders may reject Uninsured Motorist
3 coverage limits or select Uninsured Motorist coverage with limits
4 higher than \$25,000.00 per person/\$50,000.00 per occurrence. No
5 notice shall be required to existing policyholders who have rejected
6 Uninsured Motorist coverage or have selected Uninsured Motorist
7 coverage limits equal to or greater than \$25,000.00 per
8 person/\$50,000.00 per occurrence. For purposes of this subsection
9 an existing policyholder is a policyholder who purchased a policy
10 from the insurer before April 1, 2005, and such policy renews on or
11 after April 1, 2005.

12 SECTION 2. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 7-611 of Title 47, unless there
14 is created a duplication in numbering, reads as follows:

15 A. Except as provided in subsection B of this section, in any
16 civil action to recover damages arising out of an accident involving
17 the operation of a motor vehicle or for any claim against another
18 party's motor vehicle liability insurance coverage, the maximum
19 amount that a plaintiff or claimant may receive, if the plaintiff or
20 claimant is not in compliance with the Compulsory Insurance Law,
21 shall be limited to the amount of medical costs, property damage,
22 and lost income and shall not include any award for pain and
23 suffering.

24

1 B. The limitations provided for in subsection A of this section
2 shall not apply:

3 1. If the plaintiff or claimant was injured by a motorist who
4 at the time of the accident was operating or using a motor vehicle
5 while intoxicated in violation of any provision of law relating to
6 the illegal operation or use of a motor vehicle while intoxicated,
7 and that motorist was convicted of, or pled guilty or nolo
8 contendere to, the offense;

9 2. If the plaintiff or claimant was a passenger in a motor
10 vehicle involved in the accident, unless the plaintiff or claimant
11 is an owner of the vehicle;

12 3. If the plaintiff or claimant was not in any motor vehicle
13 involved in the accident;

14 4. To wrongful death claims; or

15 5. If the motorist who caused the accident:

16 a. intentionally causes the accident,

17 b. leaves the scene of the accident, or

18 c. at the time of the accident, is acting in furtherance
19 of the commission of a felony.

20 C. Each person who is involved in the accident which is the
21 basis for the action or claim by the plaintiff or claimant and who
22 is found liable for damages to the plaintiff or claimant may assert
23 the limitation of recovery provided for in subsection A of this
24 section, unless any of the provisions of subsection B of this

1 section apply. The person's motor vehicle liability insurer also
2 may assert the limitation.

3 SECTION 3. REPEALER 47 O.S. 2001, Section 7-608, as
4 amended by Section 7, Chapter 322, O.S.L. 2006 (47 O.S. Supp. 2006,
5 Section 7-608), is hereby repealed.

6 SECTION 4. This act shall become effective November 1, 2007.
