13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. There is hereby appropriated to the State Board of
15 Education from any monies not otherwise appropriated from the
16 General Revenue Fund of the State Treasury for the fiscal year
17 ending June 30, 2009, the sum of _____ Dollars (\$0.00) or so
18 much thereof as may be necessary for the financial support of public
19 schools.

20 SECTION 2. The State Board of Education is hereby authorized to
21 expend during the fiscal year ending June 30, 2009, from the
22 Education Reform Revolving Fund created in Section 41.29b of Title
23 62 of the Oklahoma Statutes, the sum of _____ Dollars (\$0.00)

1 or so much thereof as may be necessary for the financial support of
2 public schools.

3 SECTION 3. There is hereby appropriated to the State Board of
4 Education from the Oklahoma Education Lottery Trust Fund of the
5 State Treasury for the fiscal year ending June 30, 2009, the sum of
6 _____ Dollars (\$0.00) or so much thereof as may be necessary for
7 certified employee salary increases for the fiscal year ending June
8 30, 2009, in the support of public school activities.

9 SECTION 4. There is hereby appropriated to the State Board of

19 much thereof as may be necessary to perform the duties imposed upon
20 the Oklahoma Water Resources Board by law.

21 SECTION 126. There is hereby appropriated to the Oklahoma Water
22 Resources Board from any monies not otherwise appropriated from the
23 General Revenue Fund of the State Treasury for the fiscal year
