7 An Act relating to professions and occupations;
8 amending 59 O.S. 2001, Sections 887.13 and 887.17, as
9 last amended by Section 1, Chapter 84, O.S.L. 2005
10 (59 O.S. Supp. 2007, Section 887.17), which relate to
11 the Physical Therapy Practice Act; expanding referral
12 list; and declaring an emergency.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY 59 O.S. 2001, Section 887.13, is
15 amended to read as follows:

16 Section 887.13 The State Board of Medical Licensure and
17 Supervision may refuse to issue or renew, or may suspend or revoke a
18 license to any person, after notice and hearing in accordance with
19 rules and regulations promulgated pursuant to the Physical Therapy
20 Practice Act and the provisions of the Administrative Procedures Act
21 of the Oklahoma Statutes who has:

22 1. Practiced physical therapy other than under the referral of
23 a physician, surgeon, dentist, chiropractor or podiatrist duly
24 licensed to practice medicine or surgery, a physician assistant, or
in the case of practice as a physical therapist assistant, has

1 practiced other than under the direction of a licensed physical
2 therapist;

3 2. Treated or attempted to treat ailments or other health
4 conditions of human beings other than by physical therapy as
5 authorized by the Physical Therapy Practice Act;

6 3. Failed to refer patients to other health care providers if
7 symptoms are known to be present for which physical therapy
8 treatment is inadvisable or if symptoms indicate conditions for
9 which treatment is outside the standards of practice as specified in
10 the rules and regulations promulgated by the Board pursuant to the
11 provisions of the Physical Therapy Practice Act;

12 4. Used drugs, narcotics, medication, or intoxicating liquors
13 to an extent which affects the professional competency of the
14 applicant or licensee;

15 5. Been convicted of a felony or of a crime involving moral
16 turpitude;

17 6. Obtained or attempted to obtain a license as a physical
18 therapist or physical therapist assistant by fraud or deception;

19 7. Been grossly negligent in the practice of physical therapy
20 or in acting as a physical therapist assistant;

21 8. Been adjudged mentally incompetent by a court of competent
22 jurisdiction and has not subsequently been lawfully declared sane;

23 9. Been guilty of conduct unbecoming a person licensed as a
24 physical therapist or physical therapist assistant or guilty of

1 | conduct detrimental to the best interests of the public or ~~his~~ the
2 | profession;

3 | 10. Been guilty of any act in conflict with the ethics of the
4 | profession of physical therapy; or

5 | 11. Had ~~his~~ a license suspended or revoked in another state.

6 | SECTION 2. AMENDATORY 59 O.S. 2001, Section 887.17, as
7 | last amended by Section 1, Chapter 84, O.S.L. 2005 (59 O.S. Supp.
8 | 2007, Section 887.17), is amended to read as follows:

9 | Section 887.17 A. 1. Any person licensed under this act as a
10 | physical therapist or physical therapist assistant shall treat human
11 | ailments by physical therapy only under the referral of a person
12 | licensed as a physician or surgeon with unlimited license, or the
13 | physician assistant of the person so licensed, and Doctors of
14 | Dentistry, Chiropractic and Podiatry, with those referrals being
15 | limited to their respective areas of training and practice;
16 | provided, however, a physical therapist may provide services within
17 | the scope of physical therapy practice without a physician referral
18 | to children who receive physical therapy services pursuant to the
19 | Individuals with Disabilities Education Improvement Act of 2004, as
20 | may be amended, and the Rehabilitation Act of 1973, Section 504, as
21 | may be amended. Provided further, a plan of care developed by a
22 | person authorized to provide services within the scope of the
23 | Physical Therapy Practice Act shall be deemed to be a prescription
24 | for purposes of providing services pursuant to the provisions of the

1 Individuals with Disabilities Education Improvement Act of 2004, as
2 may be amended, and Section 504 of the Rehabilitation Act of 1973,
3 as may be amended.

4 2. Nothing in this act shall prevent a physical therapist from
5 performing screening and educational procedures within the scope of
6 physical therapy practice without a physician referral.

7 3. Nothing in this act shall be construed as authorization for
8 a physical therapist or physical therapist assistant to practice any
9 branch of the healing art.

10 4. Any person violating the provisions of this act shall be
11 guilty of a misdemeanor as per Section 887.16 of this title.

12 B. 1. The provisions of this act are not intended to limit the
13 activities of persons legitimately engaged in the nontherapeutic
14 administration of baths, massage, and normal exercise.

15 2. This act shall not prohibit students who are enrolled in
16 schools of physical therapy approved by the State Board of Medical
17 Licensure and Supervision from performing such work as is incidental
18 to their course of study; nor shall it prevent any student in any
19 recognized school of the healing art in carrying out prescribed
20 courses of study; provided such school is a recognized institution
21 by the statutes of Oklahoma, and its practitioners are duly licensed
22 as prescribed by law.

23 3. Nothing in this act shall apply to any person employed by an
24 agency, bureau, or division of the federal government while in the

1 discharge of official duties, however, if such individual engages in
2 the practice of physical therapy outside the line of official duty,
3 the individual must be licensed as herein provided.

4 SECTION 3. It being immediately necessary for the preservation
5 of the public peace, health and safety, an emergency is hereby
6 declared to exist, by reason whereof this act shall take effect and
7 be in full force from and after its passage and approval.
