13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. There is hereby appropriated to the Oklahoma
15 Department of Veterans Affairs from any monies not otherwise
16 appropriated from the General Revenue Fund of the State Treasury for
17 the fiscal year ending June 30, 2009, the sum of _____
18 Dollars (\$0.00) or so much thereof as may be necessary to perform
19 the duties imposed upon the Oklahoma Department of Veterans Affairs
20 by law.

21 SECTION 2. For the fiscal year ending June 30, 2009, the
22 Oklahoma Department of Veterans Affairs shall budget all funds in
23 the following categories and amounts:

7 each budget category.

8 SECTION 3. The duties and compensation of employees, not
9 otherwise prescribed by law, necessary to perform the duties imposed
10 upon the Oklahoma Department of Veterans Affairs by law shall be set
11 by the Director. The salary of the Director shall not exceed _____
12 (\$0.00) per annum, payable monthly for the fiscal year ending June
13 30, 2009. The Oklahoma Department of Veterans Affairs for the
14 fiscal year ending June 30, 2009, shall be subject to the following
15 budgetary limitations on full-time-equivalent employees, except as
16 may be authorized pursuant to the provisions of Section 3603 of
17 Title 74 of the Oklahoma Statutes:
