An Act relating to the Oklahoma Health Care Authority; amending Sections 71, 73 and 74 of Enrolled House Bill No. 2276 of the 2nd Session of the 51st Oklahoma Legislature, which relate to appropriations to the Oklahoma Health Care Authority; modifying appropriation amounts; providing an effective date; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY Section 71 of Enrolled House Bill No. 2276 of the 2nd Session of the 51st Oklahoma Legislature, is amended to read as follows:

Section 71. There is hereby appropriated to the Oklahoma Health Care Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2009, the sum of ~~Seven Hundred Eleven Million Four Hundred Seventy two Thousand Two Hundred Sixty one Dollars~~ ~~(\$711,472,261.00)~~ Six Hundred Ninety Million Seven Hundred Eighty-seven Thousand Nine Hundred Thirty-two Dollars (\$690,787,932.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Health Care Authority by law.

SECTION 2. AMENDATORY Section 73 of Enrolled House Bill No. 2276 of the 2nd Session of the 51st Oklahoma Legislature, is amended to read as follows:

Section 73. There is hereby appropriated to the Oklahoma Health Care Authority from the 245 Fund of the Oklahoma Health Care Authority, the sum of ~~One Hundred Million Dollars (\$100,000,000.00)~~ One Hundred Eight Million Two Hundred Seventeen Thousand Ninety Dollars (\$108,217,090.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Health Care Authority by law.

SECTION 3. AMENDATORY Section 74 of Enrolled House Bill No. 2276 of the 2nd Session of the 51st Oklahoma Legislature, is amended to read as follows:

Section 74. There is hereby appropriated to the Oklahoma Health Care Authority from any monies not otherwise appropriated from the Tobacco Settlement Fund of the State, the sum of ~~Fourteen Million One Hundred Fifty Thousand Dollars (\$14,150,000.00)~~ Twenty-six Million Six Hundred Seventeen Thousand Two Hundred Thirty-nine Dollars (\$26,617,239.00) or so much thereof as may be necessary to perform the duties imposed upon the Health Care Authority by law.

SECTION 4. This act shall become effective July 1, 2008.

SECTION 5. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
