An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the Oklahoma Arts Council, the State Board of Education, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, the Oklahoma Department of Libraries, the Commissioners of the Land Office, the Physician Manpower Training Commission, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Oklahoma Commission for Teacher Preparation, the State Board of Career and Technology Education, the Oklahoma Board of Private Vocational Schools, the Oklahoma Tax Commission, the State Board of Education, the Office of the State Auditor and Inspector, the Rural Economic Action Plan Fund, the Office of the State Bond Advisor, the Department of Central Services, the Oklahoma Department of Emergency Management, the State Election Board, the Ethics Commission, the Office of State Finance, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Office of Personnel Management, the

Office of the Secretary of State, the Oklahoma State Senate, the Oklahoma Tax Commission, the Office of the State Treasurer, the Oklahoma Space Industry Development Authority, the Department of Transportation, the Oklahoma Commission on Children and Youth, the Office of Handicapped Concerns, the Oklahoma Human Rights Commission, the Department of Human Services, the State Department of Rehabilitation Services, the Oklahoma Indian Affairs Commission, the Office of Juvenile Affairs, the Department of Mental Health and Substance Abuse Services, the State Department of Health, the University Hospitals Authority, the Oklahoma Health Care Authority, the J.D. McCarty Center for Children with Developmental Disabilities, the Oklahoma Department of Veterans Affairs, the Oklahoma Department of Agriculture, Food, and Forestry, the Oklahoma Capitol Complex and Centennial Commemoration Commission, the Oklahoma Department of Commerce, the Oklahoma Conservation Commission, the Department of Consumer Credit, the Corporation Commission, the Department of Environmental Quality, the Oklahoma Historical Society, the Oklahoma Horse Racing Commission, the Insurance Department, the J.M. Davis Memorial Commission, the Department of Labor, the Department of Mines, the Scenic Rivers Commission, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Will Rogers Memorial Commission, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the Office of the State Fire Marshal, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Board of Medicolegal Investigations, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Pardon and Parole Board, the Department of Public Safety, the Office of the Attorney General, district attorneys and the District Attorneys Council, the Court of Criminal Appeals, the Supreme Court, the Council on Judicial Complaints, the Workers' Compensation Court, and the Oklahoma Indigent Defense System; stating sums of the

appropriations; stating purposes and restrictions; authorizing and requiring certain expenditures; requiring transfer of certain funds; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SUBCOMMITTEE ON EDUCATION

SECTION 1. There is hereby appropriated to the Oklahoma Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Five Million One Hundred Fifty Thousand Nine Hundred Sixty-seven Dollars (\$5,150,967.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Arts Council by law.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of One Billion Two Hundred Forty-seven Million Three Hundred Thirty-two Thousand One Hundred Forty-two Dollars (\$1,247,332,142.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Education Reform Revolving Fund created in Section 41.29b of Title 62 of the Oklahoma Statutes, the sum of Six Hundred Forty-eight Million Two Hundred Twenty-four Thousand Two Hundred Twenty-three Dollars (\$648,224,223.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2008, from the Common Education Technology Revolving Fund of the State Treasury, the sum of Fifty Million Three Hundred Seventy-four Thousand Two Hundred Eighty-four Dollars (\$50,374,284.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education, from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Four Million Five Hundred Sixty Thousand Dollars (\$4,560,000.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 6. There is hereby appropriated to the State Board of Education, from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Two Million Two Hundred Twenty-six Thousand Nine Hundred Eighty-one Dollars (\$2,226,981.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 7. There is hereby appropriated to the State Board of Education from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Thirty-six Million Eight Hundred Sixty-one Thousand Nine Hundred Eighty-four Dollars (\$36,861,984.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 8. There is hereby appropriated to the State Board of Education from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Three Million Four Thousand Eight Hundred Ninety-three Dollars (\$3,004,893.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 9. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Four Hundred Fifteen Million Four Hundred Eighty-four Thousand One Hundred Thirty-seven Dollars (\$415,484,137.00) or so much thereof as may be necessary for the support of public school activities.

SECTION 10. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Thirty-three

Million Dollars (\$33,000,000.00) or so much thereof as may be necessary for the purchase of textbooks.

SECTION 11. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2007, the sum of Five Million Nine Hundred Seventy-one Thousand Seven Hundred Fifteen Dollars (\$5,971,715.00) or so much thereof as may be necessary for the purpose of funding Education Leadership Oklahoma.

SECTION 12. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Twenty-four Million Two Hundred Fifty-five Thousand Five Hundred Forty-two Dollars (\$24,255,542.00) or so much thereof as may be necessary for administrative and support functions of the State Department of Education.

SECTION 13. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Four Million Ninety-five Thousand Seven Hundred Seventy-six Dollars (\$4,095,776.00) or so much thereof as may be necessary for transfer to the School Consolidation Assistance Fund.

SECTION 14. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Three Hundred Thirty-three Thousand Eight Hundred Seventy-seven Dollars (\$333,877.00) or so much thereof as may be necessary for transfer to the School Consolidation Assistance Fund.

SECTION 15. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Four Million Ninety-five Thousand Seven Hundred Seventy-six Dollars (\$4,095,776.00) or so much thereof as may be necessary for transfer to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

SECTION 16. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Three Hundred Thirty-three Thousand Eight Hundred Seventy-seven Dollars (\$333,877.00) or so much thereof as may be necessary for transfer to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

SECTION 17. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Eight Million Three Hundred Ninety-four Thousand Three Hundred Eighty-three Dollars (\$8,394,383.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 18. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Eight Hundred Fifty-two Million Six Hundred Sixteen Thousand Three Hundred Forty-one Dollars (\$852,616,341.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education. Of those funds appropriated, the sum of Four Million Three Hundred Forty-four Thousand Six Hundred Fifty Dollars (\$4,344,650.00) shall be transferred to the Oklahoma Tuition Equalization Grant Trust Fund to implement the provisions of the Oklahoma Tuition Equalization Grant Act.

SECTION 19. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2008, the sum of Fifty Million Three Hundred Seventy-four Thousand Two Hundred Eighty-four Dollars (\$50,374,284.00) from the Higher Education Capital Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma

Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 20. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2008, the sum of Fifty Million Three Hundred Seventy-four Thousand Two Hundred Eighty-four Dollars (\$50,374,284.00) from the Oklahoma Student Aid Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 21. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Nine Million Four Hundred One Thousand Four Hundred Six Dollars (\$9,401,406.00) for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 22. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2008, the sum of Ten Million Seven Hundred Fifty Thousand Two Hundred Thirty-eight Dollars (\$10,750,238.00) from the Oklahoma Higher Learning Access Trust Fund of the State Treasury or so much thereof as may be necessary for expenditures in the Oklahoma Higher Learning Access Program.

SECTION 23. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Thirty-seven Million Three Hundred Fifty-four Thousand Seven Hundred Sixty-two Dollars (\$37,354,762.00) or so much thereof as may be necessary for expenditures in the Oklahoma Higher Learning Access Program.

SECTION 24. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of One Million Four Hundred Thousand Dollars (\$1,400,000.00) or so much thereof as may be necessary for expenditures for concurrent enrollment pursuant to Section 628.13 of Title 70 of the Oklahoma Statutes.

SECTION 25. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Thirty-two Million Three Hundred Sixty-one Thousand Nine Hundred Eighty-three Dollars (\$32,361,983.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education or for any other purpose authorized by paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes.

SECTION 26. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Three Million Four Thousand Eight Hundred Ninety-two Dollars (\$3,004,892.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education or for any other purpose authorized by paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes.

SECTION 27. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Five Million Five Hundred Sixty-one Thousand Two Hundred Sixty-six Dollars

(\$5,561,266.00) or so much thereof as may be necessary for the general operating budget of the Administrative Offices of the Oklahoma State Regents for Higher Education.

SECTION 28. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Seven Hundred Fifty Thousand One Hundred Twenty Dollars (\$750,120.00) or so much thereof as may be necessary for the Office of Accountability to perform the duties imposed upon the Office of Accountability by law.

SECTION 29. There is hereby appropriated to the Oklahoma Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Seven Million Two Hundred Ninety-four Thousand Eight Hundred Fifty-six Dollars (\$7,294,856.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Libraries by law.

SECTION 30. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Four Million Eight Hundred Sixty-four Thousand Eight Hundred Eighty-one Dollars (\$4,864,881.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 31. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Five Million One Hundred Twenty-three Thousand Five Hundred Two Dollars (\$5,123,502.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 32. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Four Hundred Thousand Dollars (\$400,000.00) or so much

thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 33. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Seven Million Five Hundred Eighty-five Thousand Seven Hundred Thirty-two Dollars (\$7,585,732.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 34. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Twenty-two Million Four Hundred Fifty-six Thousand Five Hundred Seven Dollars (\$22,456,507.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law.

SECTION 35. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Two Million Fifty-nine Thousand Nine Hundred Eighty-two Dollars (\$2,059,982.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

SECTION 36. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of One Hundred Fifty Million Three Hundred Sixty-four Thousand Three Hundred Ninety-one Dollars (\$150,364,391.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Career and Technology Education by law.

SECTION 37. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of

Four Million Five Hundred Thousand Dollars (\$4,500,000.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the State Board of Career and Technology Education for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the State Board of Career and Technology Education.

SECTION 38. The Oklahoma Board of Private Vocational Schools is hereby authorized to expend during the fiscal year ending June 30, 2008, from the Oklahoma Board of Private Vocational Schools Revolving Fund of the State Treasury, the sum of One Hundred Ninety-three Thousand Three Hundred Four Dollars (\$193,304.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Private Vocational Schools by law.

SUBCOMMITTEE ON GENERAL GOVERNMENT AND TRANSPORTATION

SECTION 39. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Five Million Nine Hundred Fifteen Thousand Two Hundred Sixty-nine Dollars (\$5,915,269.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 40. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Four Hundred Thousand Dollars (\$400,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 41. There is hereby appropriated to the Rural Economic Action Plan Fund of the State Treasury from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Fifteen Million Five Hundred Thousand Dollars (\$15,500,000.00) or so much thereof as

may be necessary to implement the provisions of Sections 2006 through 2013 of Title 62 of the Oklahoma Statutes.

SECTION 42. There is hereby appropriated to the Office of the State Bond Advisor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of One Hundred Eighty-six Thousand Four Hundred Nineteen Dollars (\$186,419.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Bond Advisor by law.

SECTION 43. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Sixteen Million Three Hundred Eighty-six Thousand Seven Hundred Fifty-eight Dollars (\$16,386,758.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Central Services by law.

SECTION 44. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of One Hundred Fifty-one Thousand Five Hundred Eighteen Dollars (\$151,518.00) or so much thereof as may be necessary to maintain the Hissom Memorial Center.

SECTION 45. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2006, the sum of Eight Hundred Twenty Thousand Eight Hundred Seventy-six Dollars (\$820,876.00) to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 46. There is hereby appropriated to the Department of Central Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of One Million Six Hundred Ninety-four Thousand Five Hundred Forty-five Dollars (\$1,694,545.00) or so much thereof as may be necessary to be transferred to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the

Oklahoma Statutes for the purpose of maintaining state buildings operated by the Department of Central Services.

SECTION 47. There is hereby appropriated to the Oklahoma Department of Emergency Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Eight Hundred Thirty-six Thousand Six Hundred Four Dollars (\$836,604.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Emergency Management by law.

SECTION 48. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Six Million Eight Hundred Five Thousand Nine Hundred Eighty-eight Dollars (\$6,805,988.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 49. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Nine Hundred Eighty Thousand Dollars (\$980,000.00) or so much thereof as may be required to pay the necessary expenses of holding elections.

SECTION 50. (\$30,796,274.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Corrections by law.

SECTION 111. There is hereby appropriated to the Office of the State Fire Marshal from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Two Million Two Hundred Seventy Thousand Eight Hundred Fifty-five Dollars (\$2,270,855.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Fire Marshal by law.

SECTION 112. There is hereby appropriated to the Oklahoma State Bureau of Investigation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Seventeen Million Three Hundred Sixteen Thousand Four Hundred Fifty Dollars (\$17,316,450.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Bureau of Investigation by law.

SECTION 113. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the C.L.E.E.T. Fund for the fiscal year ending June 30, 2008, the sum of Three Million Four Hundred Twenty-seven Thousand Seventy-six Dollars (\$3,427,076.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 114. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the C.L.E.E.T. Fund for the fiscal year ending June 30, 2006, the sum of Three Hundred Ninety-five Thousand Seven Hundred Thirty-seven Dollars (\$395,737.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 115. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Five Hundred Eighty-seven Thousand Five Hundred Fifty-seven Dollars (\$587,557.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 116. There is hereby appropriated to the Board of Medicolegal Investigations from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Four Million Eight Hundred Twenty-five Thousand Six Hundred Twenty-five Dollars (\$4,825,625.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Medicolegal Investigations by law.

SECTION 117. There is hereby appropriated to the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Six Million Seven Hundred Seventy-three Thousand Eight Hundred Ninety-five Dollars (\$6,773,895.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control by law.

SECTION 118. There is hereby appropriated to the Pardon and Parole Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Two Million Five Hundred Seventy-seven Thousand Five Hundred Eighty-one Dollars (\$2,577,581.00) or so much thereof as may be necessary to perform the duties imposed upon the Pardon and Parole Board by law.

SECTION 119. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Ninety-eight Million Three Hundred Seventy Thousand Three Hundred Ninety-one Dollars (\$98,370,391.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law.

SECTION 120. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Thirteen Million Nine Hundred Forty-four Thousand Four Hundred Forty-nine Dollars (\$13,944,449.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Attorney General by law.

SECTION 121. For the fiscal year ending June 30, 2008, the Office of the Attorney General is authorized to transfer an amount not to exceed Three Hundred Twenty Thousand Four Hundred Thirty Dollars (\$320,430.00) from the Office of the Attorney General's Evidence Fund (700 Fund), created by Section 19 of Title 74 of the Oklahoma Statutes to the Office of the Attorney General's Revolving Fund (200 Fund) created by Section 20 of Title 74 of the Oklahoma Statutes.

SECTION 122. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Thirty-nine Million Nine Hundred Twenty Thousand Two Hundred Ten Dollars (\$39,920,210.00) or so much thereof as may be necessary to perform the duties imposed upon the district attorneys and the District Attorneys Council by law. Of the funds appropriated herein, the Office of the Attorney General shall transfer up to the sum of Four Hundred Ninety-one Thousand Fourteen Dollars (\$491,014.00) or so much thereof as may be required by the district attorneys and District Attorneys Council to the District Attorneys Evidence Fund for necessary expenses relative to any case within the official responsibility of the offices of the district attorneys as provided by Section 215.40 of Title 19 of the Oklahoma Statutes.

SECTION 123. For the fiscal year ending June 30, 2008, the District Attorneys Council is authorized to transfer an amount not to exceed Six Hundred Thousand Dollars (\$600,000.00), on an as-needed basis, from the Crime Victims Compensation Revolving Fund created by Section 142.17 of Title 21 of the Oklahoma Statutes to the Sexual Assault Examination Fund created by Section 142.20 of Title 21 of the Oklahoma Statutes.

SECTION 124. For the fiscal year ending June 30, 2008, up to Five Hundred Twenty-five Thousand Dollars (\$525,000.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes to the District Attorneys Council for eleven (11) employees, including related duties to support the Crime Victims Compensation Board.

SECTION 125. For the fiscal year ending June 30, 2008, up to One Million Three Hundred One Thousand Three Hundred Seventy-five Dollars (\$1,301,375.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes, to the District Attorneys Council for duties to support Victim-Witness Services.

SECTION 126. There is hereby appropriated to the Court of Criminal Appeals from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Three Million Four Hundred Eighty-nine Thousand Six Hundred Thirty-one Dollars (\$3,489,631.00) or so much thereof as may be necessary to perform the duties imposed upon the Court of Criminal Appeals by law.

SECTION 127. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Seventeen Million Five Thousand Seven Hundred Twenty-five Dollars (\$17,005,725.00) or so much thereof as may be necessary to perform the duties imposed upon the Supreme Court or Court of Civil Appeals by law.

SECTION 128. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of One Million One Hundred Sixty-four Thousand Eight Hundred Forty-five Dollars (\$1,164,845.00) to transfer to the Legal Services Revolving Fund created pursuant to subsection G of Section 921.1 of Title 12 of the Oklahoma Statutes.

SECTION 129. There is hereby appropriated to the Supreme Court for deposit in the Supreme Court Revolving Fund from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Nine Hundred Fifty Thousand Dollars (\$950,000.00) for expenditures authorized by Section 1310.1 of Title 20 of the Oklahoma Statutes.

SECTION 130. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Three Hundred Thousand

Dollars (\$300,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Supreme Court by law.

SECTION 131. The Supreme Court is hereby authorized to expend during the fiscal year ending June 30, 2008, from the State Judicial Revolving Fund of the State Treasury, the sum of Thirty-six Million Two Hundred Twenty-four Thousand Six Hundred Sixty-one Dollars (\$36,224,661.00) or so much thereof as may be necessary for the financial support of the District Courts.

SECTION 132. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Twenty-one Million Four Hundred Fifty Thousand One Hundred Seventeen Dollars (\$21,450,117.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 133. There is hereby appropriated to the Council on Judicial Complaints from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Two Hundred Eighty-three Thousand Seven Hundred Twenty-nine Dollars (\$283,729.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Judicial Complaints by law.

SECTION 134. There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Five Million Two Hundred Forty-two Thousand Thirty-three Dollars (\$5,242,033.00) or so much thereof as may be necessary to perform the duties imposed upon the Workers' Compensation Court by law.

SECTION 135. There is hereby appropriated to the Oklahoma Indigent Defense System from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of Sixteen Million Three Hundred Four Thousand Eight Dollars (\$16,304,008.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Indigent Defense System by law.

SECTION 136. This act shall become effective July 1, 2007.
