A Concurrent Resolution relating to rules of the Teachers' Retirement System of Oklahoma; waiving thirty-legislative-day review period for proposed permanent rules OAC 715:10-1-6, OAC 715:10-5-4, OAC 715:10-13-3.1, OAC 715:10-15-6, OAC 715:10-15-11, OAC 715:10-19-7, OAC 715:10-19-8, OAC 715:10-21-2, OAC 715:10-21-3, OAC 715:10-21-4, OAC 715:10-21-5, OAC 715:10-23-1, OAC 715:10-23-2, OAC 715:10-23-3, OAC 715:10-23-5, and OAC 715:10-25-2, which relate to retirement; and directing distribution.

WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma Statutes, the Legislature may waive the thirty-legislative-day review period for any rule which has been transmitted for legislative review; and

WHEREAS, on April 2, 2008, the Teachers' Retirement System of Oklahoma submitted to the Legislature for its review proposed permanent rules OAC 715:10-1-6, OAC 715:10-5-4, OAC 715:10-13-3.1, OAC 715:10-15-6, OAC 715:10-15-11, OAC 715:10-19-7, OAC 715:10-19-8, OAC 715:10-21-2, OAC 715:10-21-3, OAC 715:10-21-4, OAC 715:10-21-5, OAC 715:10-23-1, OAC 715:10-23-2, OAC 715:10-23-3, OAC 715:10-23-5, and OAC 715:10-25-2, which relate to retirement.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 2ND SESSION OF THE 51ST OKLAHOMA LEGISLATURE, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

THAT the Legislature hereby waives the thirty-legislative-day review period of proposed permanent rules OAC 715:10-1-6, OAC 715:10-5-4, OAC 715:10-13-3.1, OAC 715:10-15-6, OAC 715:10-15-11, OAC 715:10-19-7, OAC 715:10-19-8, OAC 715:10-21-2, OAC 715:10-21-3, OAC 715:10-21-4, OAC 715:10-21-5, OAC 715:10-23-1, OAC 715:10-23-2, OAC 715:10-23-3, OAC 715:10-23-5, and OAC 715:10-25-2.

THAT a copy of this resolution be distributed to the Governor, the President Pro Tempore and Co-President Pro Tempore of the Senate, the Speaker of the House of Representatives, the Board of Trustees of the Teachers' Retirement System of Oklahoma, and the Editor of "The Oklahoma Register".
