10 FLOOR SUBSTITUTE

11 An Act relating to the State Board of Education;
12 making appropriations to the State Board of
13 Education; stating purposes; making appropriations
14 nonfiscal; making appropriations exempt from certain
15 agency category and budget limits; and declaring an
16 emergency.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. There is hereby appropriated to the State Board of
19 Education from any monies not otherwise appropriated from the
20 General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2007, the sum of Ten Million Dollars
22 (\$10,000,000.00) or so much thereof as may be necessary for the
23 financial support of public schools.

24 SECTION 2. There is hereby appropriated to the State Board of
Education from any monies not otherwise appropriated from the

1 General Revenue Fund of the State Treasury for the fiscal year
2 ending June 30, 2007, the sum of One Million Five Hundred Thousand
3 Dollars (\$1,500,000.00) or so much thereof as may be necessary for
4 the purpose of funding Academic Achievement Awards pursuant to the
5 provisions of Section 3-152.1 of Title 70 of the Oklahoma Statutes.

6 SECTION 3. The appropriations made by this act shall not be
7 subject to fiscal year limitations and shall be available for
8 encumbrance and expenditure purposes for a period of thirty (30)
9 months from the date this act is approved.

10 SECTION 4. The appropriations made by this act shall not be
11 subject to fiscal years 2008 and 2009 agency category and budget
12 limits.

13 SECTION 5. It being immediately necessary for the preservation
14 of the public peace, health and safety, an emergency is hereby
15 declared to exist, by reason whereof this act shall take effect and
16 be in full force from and after its passage and approval.
