1 "SECTION 1. The Secretary of State shall refer to the people  
2 for their approval or rejection, as and in the manner provided by  
3 law, the following proposed amendment to the Constitution of the  
4 State of Oklahoma by adding a new Section 36 to Article VI thereof,  
5 to read as follows:

6 Section 36. A. There is hereby established a Tax  
7 Identification Division within the Oklahoma Tax Commission, which  
8 shall be charged with the execution of all laws which shall  
9 hereafter be passed in relation to voluntary tax identification  
10 programs within the state. The Tax Identification Division shall be  
11 responsible for the creation and issuance of voluntary tax  
12 identification cards to persons who are either residing or employed  
13 in this state and who have or are seeking United States citizenship  
14 or legal residency or employment status or the attorney of such a  
15 person.

16 B. A fee of One Thousand Dollars (\$1,000.00) shall be charged  
17 to every person that applies for the tax identification card. Any  
18 person who applies for the tax identification card shall be required  
19 to provide personal information, as determined by the Division, and  
20 shall submit to computerized finger imaging. The tax identification  
21 card shall be valid for one (1) year, but may be renewed annually.  
22 The annual renewal fee shall be One Thousand Dollars (\$1,000.00).  
23 Each tax identification card issued to an applicant shall have a  
24 corresponding identification number.

1 C. All records and information obtained pursuant to the  
2 voluntary tax identification card program shall be confidential and  
3 privileged. Neither the Tax Identification Division nor any  
4 employee engaged in the administration of the tax identification  
5 program shall disclose any information obtained from the records or  
6 files of the Tax Identification Division.

7 D. Any person who has been issued a tax identification card and  
8 has paid the fees required by this section shall not be subject to  
9 any law of this state that requires other identification  
10 documentation based solely on the fact that the person is a foreign  
11 national. This subsection shall not exempt a person from any  
12 requirement to obtain documentation that has some purpose other than  
13 identification, such as a driver license or a professional license  
14 required by the laws of this state.

15 E. The Tax Identification Division shall be responsible for  
16 such other duties as prescribed by law.

17 F. The Oklahoma Tax Commission shall promulgate rules to  
18 implement this section.

19 SECTION 2. The Ballot Title for the proposed Constitutional

24 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

1 This measure amends the Oklahoma Constitution. It creates a new  
2 division within the Tax Commission. The new division will  
3 create and issue tax identification cards. A fee will be  
4 charged for the tax identification cards. If a person has a tax  
5 identification card, the person will not need other  
6 identification papers. The person would still need to have a  
7 driver license to drive. The person would still need to have  
8 required professional licensing. All records and information  
9 will be kept confidential and will not be disclosed. The new  
10 division will have other duties as prescribed by law. The Tax  
11 Commission would have to come up with rules for this amendment.
