9 A Joint Resolution modifying certain provisions of
10 Article IX of the Oklahoma Constitution by removing
11 certain sections from Article IX to Title 17 of the
12 Oklahoma Statutes; repealing Sections 18b, 21 and 27
13 of Article IX of the Oklahoma Constitution, which
14 relate to the Corporation Commission; providing for
15 recodification; and providing an effective date.

16 WHEREAS, Section 35 of Article IX of the Oklahoma Constitution
17 provides:

18 "After the second Monday in January, nineteen hundred and nine,
19 the Legislature may, by law, from time to time, alter, amend,
20 revise, or repeal sections from eighteen to thirty-four, inclusive,
21 of this article, or any of them, or any amendments thereof:

22 Provided, That no amendment made under authority of this section
23 shall contravene the provisions of any part of this Constitution
24 other than the said sections last above referred to or any such
amendments thereof."

1 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
2 AND THE SENATE OF THE 2ND SESSION OF THE 51ST OKLAHOMA LEGISLATURE:

3 SECTION 1. RECODIFICATION Article IX, Sections 18, 19,
4 20, 22, 24, 25, 26, 28, 29, 30, 31, 32, 33 and 34, of the Oklahoma
5 Constitution, shall be recodified as Sections 1A, 2A, 3B, 5A, 6.2,
6 25, 75, 13A, 13B, 161.2, 180.12, 71.1, 76 and 180.13, respectively
7 of Title 17 of the Oklahoma Statutes, unless there is created a
8 duplication in numbering.

9 SECTION 2. RECODIFICATION 17 O.S. 2001, Section 1, shall
10 be recodified as Section 1B of Title 17 of the Oklahoma Statutes,
11 unless there is created a duplication in numbering.

12 SECTION 3. REPEALER Article IX, Sections 18b, 21 and 27
13 of the Oklahoma Constitution, are hereby repealed.
