HOUSE BILL NO. 1115 - By: BENGE AND MILLER of the House and CRUTCHFIELD, JOHNSON (MIKE), ADELSON AND MYERS of the Senate.

An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the State Board of Education, the Commissioners of the Land Office, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Commission for Teacher Preparation, the State Board of Career and Technology Education, the Oklahoma State Regents for Higher Education, the Physician Manpower Training Commission, the Oklahoma Board of Private Vocational Schools, the Oklahoma Arts Council, the Oklahoma Capitol Complex and Centennial Commemoration Commission, the Oklahoma Educational Television Authority, the Oklahoma Historical Society, the J.M. Davis Memorial Commission, the Oklahoma Department of Libraries, the Will Rogers Memorial Commission, the State Election Board, the Ethics Commission, the Office of the Attorney General, the Court of Criminal Appeals, the District Attorneys Council, the Oklahoma Indigent Defense System, the Council on Judicial Complaints, the Pardon and Parole Board, the Supreme Court, the Workers' Compensation Court, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the State Fire Marshal, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Board of Medicolegal Investigations, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Department of Public Safety, the Oklahoma Department of Emergency Management, the Military Department of the State of Oklahoma, the Office of the State Auditor and Inspector, the Rural Economic Action Plan Fund of the State Treasury, the Office of State Finance, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Office of the Secretary of State, the Oklahoma State Senate, the Office of the State Treasurer, the Department of Transportation, the Office of the State Bond Advisor, the Department of Central Services, the Oklahoma Merit Protection Commission, the Office of Personnel Management, the Oklahoma Tax Commission, the Oklahoma Health Care Authority, the State Department of Health, the J.D.

McCarty Center for Children with Developmental Disabilities, the Department of Mental Health and Substance Abuse Services, the University Hospitals Authority, the Oklahoma Department of Veterans Affairs, the Office of Handicapped Concerns, the Department of Human Services, the State Department of Rehabilitation Services, the Oklahoma Commission on Children and Youth, the Office of Juvenile Affairs, the Oklahoma Human Rights Commission, the Oklahoma Indian Affairs Commission, the Corporation Commission, the Oklahoma Center for the Advancement of Science and Technology, the Oklahoma Space Industry Development Authority, the State Insurance Department, the Department of Consumer Credit, the Department of Labor, the Department of Mines, the Oklahoma Horse Racing Commission, the Oklahoma Department of Agriculture, Food, and Forestry, the Department of Commerce, the Oklahoma Scenic Rivers Commission, the Oklahoma Tourism and Recreation Department, the Oklahoma Conservation Commission, the Department of Environmental Quality and the Oklahoma Water Resources Board; stating amounts of appropriations; stating purposes and restrictions; authorizing and requiring certain expenditures; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. There is hereby appropriated to the State Board of Education from
2 any monies not otherwise appropriated from the General Revenue Fund of the State
3 Treasury for the fiscal year ending June 30, 2008, the sum of _____ Dollars (\$0.00)
4 or so much thereof as may be necessary for the financial support of public schools.

5 SECTION 2. The State Board of Education is hereby authorized to expend during
6 the fiscal year ending June 30, 2008, from the Education Reform Revolving Fund created
7 in Section 41.29b of Title 62 of the Oklahoma Statutes, the sum of _____ Dollars
8 (\$0.00) or so much thereof as may be necessary for the financial support of public schools.

1 SECTION 3. There is hereby appropriated to the State Board of Education from the
2 Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending
3 June 30, 2008, the sum of _____ Dollars (\$0.00) or so much thereof as may be
4 necessary for certified employee salary increases for the fiscal year ending June 30, 2008,
5 in the support of public school activities.

6 SECTION 4. There is hereby appropriated to the State Board of Education from
7 any monies not otherwise appropriated from the Mineral Leasing Fund of the State
8 Treasury for the fiscal year ending June 30, 2008, the sum of _____ Dollars (\$0.00)
9 or so much thereof as may be necessary for the financial support of public schools.

10 SECTION 5. There is hereby appropriated to the State Board of Education from
11 any monies not otherwise appropriated from the Mineral Leasing Fund of the State
12 Treasury for the fiscal year ending June 30, 2006, the sum of _____ Dollars (\$0.00)
13 or so much thereof as may be necessary for the financial support of public schools.

14 SECTION 6. The State Board of Education is hereby authorized to expend during
15 the fiscal year ending June 30, 2008, from the Common Education Technology Revolving
16 Fund of the State Treasury, the sum of _____ Dollars (\$0.00) or so much thereof as
17 may be necessary for the financial support of public schools.

18 SECTION 7. There is hereby appropriated to the State Board of Education from
19 any monies not otherwise appropriated from the Oklahoma Education Lottery Trust
20 Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of _____
21 Dollars (\$0.00) or so much thereof as may be necessary for transfer to the School
22 Consolidation Assistance Fund.

1 SECTION 8. There is hereby appropriated to the State Board of Education from
2 any monies not otherwise appropriated from the Oklahoma Education Lottery Trust
3 Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of -
4 _____ Dollars (\$0.00) or so much thereof as may be necessary for transfer to the
5 Teachers' Retirement System Dedicated Revenue Revolving Fund.

6 SECTION 9. There is hereby appropriated to the State Board of Education from
7 any monies not otherwise appropriated from the General Revenue Fund of the State
8 Treasury for the fiscal year ending June 30, 2008, the sum of _____ Dollars (\$0.00)
9 or so much thereof as may be necessary for the support of public school activities.

10 SECTION 10. There is hereby appropriated to the State Board of Education from
11 any monies not otherwise appropriated from the General Revenue Fund of the State
12 Treasury for the fiscal year ending June 30, 2008, the sum of _____ Dollars (\$0.00)
13 or so much thereof as may be necessary for the purchase of textbooks.

14 SECTION 11. There is hereby appropriated to the State Board of Education from
15 any monies not otherwise appropriated from the General Revenue Fund of the State
16 Treasury for the fiscal year ending June 30, 2008, the sum of _____ Dollars (\$0.00)
17 or so much thereof as may be necessary for Administrative and Support Functions of the
18 State Department of Education.

19 SECTION 12. There is hereby appropriated to the State Board of Education from
20 any monies not otherwise appropriated from the General Revenue Fund of the State
21 Treasury for the fiscal year ending June 30, 2008, the sum of _____ Dollars (\$0.00)

1 or so much thereof as may be necessary for the Certified Employee Health Benefit
2 Allowance.

3 SECTION 13. There is hereby appropriated to the State Board of Education from
4 any monies not otherwise appropriated from the General Revenue Fund of the State
5 Treasury for the fiscal year ending June 30, 2008, the sum of _____ Dollars (\$0.00)
6 or so much thereof as may be necessary for the Support Personnel Health Benefit
7 Allowance.

8 SECTION 14. There is hereby appropriated to the Commissioners of the Land
9 Office from any monies not otherwise appropriated from the Commissioners of the Land
10 Office Fund of the State Treasury for the fiscal year ending June 30, 2008, the sum of
11 _____ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties
12 imposed upon the Commissioners of the Land Office by law.

13 SECTION 15. There is hereby appropriated to the Board of Trustees of the
14 Oklahoma School of Science and Mathematics from any monies not otherwise
15 appropriated from the General Revenue Fund of the State Treasury for the fiscal year
16 ending June 30, 2008, the sum of _____ Dollars (\$0.00) or so much thereof as may be
17 necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma
18 School of Science and Mathematics by law.

19 SECTION 16. There is hereby appropriated to the Oklahoma Commission for
20 Teacher Preparation from any monies not otherwise appropriated from the General

7 for allocation by the Oklahoma State Regents for Higher Education pursuant to the
8 provisions of Article XIII-A of the Oklahoma Constitution for the education and general
9 operating budgets of the institutions and for other programs, construction, renovations or
10 repairs administered by the Oklahoma State Regents for Higher Education.

11 SECTION 22. The Oklahoma State Regents for Higher Education are hereby
12 authorized to expend during the fiscal year ending June 30, 2008, the sum of _____
13 Dollars (\$0.00) from the Oklahoma Tuition Scholarship Revolving Fund of the State
14 Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to
15 the provisions of Article XIII-A of the Oklahoma Constitution for the education and
16 general operating budgets of the institutions and for other programs, construction,
17 renovations or repairs administered by the Oklahoma State Regents for Higher
18 Education.

19 SECTION 23. There is hereby appropriated to the Oklahoma State Regents for
20 Higher Education from any monies not otherwise appropriated from the Oklahoma
21 Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30,
22 2008, the sum of _____ Dollars (\$0.00) pursuant to paragraph 2 of subsection C of

9 Attorneys Council for eight (8) employees, including related duties to support the Crime
10 Victims Compensation Board.
