HOUSE BILL NO. 2276 - By: MILLER AND JONES of the House and CRUTCHFIELD, JOHNSON (MIKE), ADELSON AND MYERS of the Senate.

( general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state - effective date )

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. There is hereby appropriated to the State Board of Education from  
2 any monies not otherwise appropriated from the General Revenue Fund of the State  
3 Treasury for the fiscal year ending June 30, 2009, the sum of \_\_\_\_\_ Dollars (\$0.00)  
4 or so much thereof as may be necessary for the financial support of public schools.

5 SECTION 2. The State Board of Education is hereby authorized to expend during  
6 the fiscal year ending June 30, 2009, from the Education Reform Revolving Fund created  
7 in Section 41.29b of Title 62 of the Oklahoma Statutes, the sum of \_\_\_\_\_ Dollars  
8 (\$0.00) or so much thereof as may be necessary for the financial support of public schools.

9 SECTION 3. There is hereby appropriated to the State Board of Education from the  
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending  
11 June 30, 2009, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be

1 necessary for certified employee salary increases for the fiscal year ending June 30, 2009,  
2 in the support of public school activities.

3 SECTION 4. There is hereby appropriated to the State Board of Education from  
4 any monies not otherwise appropriated from the Mineral Leasing Fund of the State  
5 Treasury for the fiscal year ending June 30, 2009, the sum of \_\_\_\_\_ Dollars (\$0.00)  
6 or so much thereof as may be necessary for the financial support of public schools.

7 SECTION 5. There is hereby appropriated to the State Board of Education from  
8 any monies not otherwise appropriated from the Mineral Leasing Fund of the State  
9 Treasury for the fiscal year ending June 30, 2007, the sum of \_\_\_\_\_ Dollars (\$0.00)  
10 or so much thereof as may be necessary for the financial support of public schools.

11 SECTION 6. The State Board of Education is hereby authorized to expend during  
12 the fiscal year ending June 30, 2009, from the Common Education Technology Revolving  
13 Fund of the State Treasury, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as  
14 may be necessary for the financial support of public schools.

15 SECTION 7. There is hereby appropriated to the State Board of Education from  
16 any monies not otherwise appropriated from the Oklahoma Education Lottery Trust  
17 Fund of the State Treasury for the fiscal year ending June 30, 2009, the sum of \_\_\_\_\_  
18 Dollars (\$0.00) or so much thereof as may be necessary for transfer to the School  
19 Consolidation Assistance Fund.

20 SECTION 8. There is hereby appropriated to the State Board of Education from  
21 any monies not otherwise appropriated from the Oklahoma Education Lottery Trust  
22 Fund of the State Treasury for the fiscal year ending June 30, 2009, the sum of -
