House Bill No. 2949

COMMITTEE SUBSTITUTE FOR HOUSE BILL NO. 2949 - By: MARTIN (SCOTT) of the House and BRANAN of the Senate.

An Act relating to amusements and sports; amending Section 3, Chapter 336, O.S.L. 2007 (3A O.S. Supp. 2007, Section 724.2), which relates to the lottery; expanding certain debt collection option; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. AMENDATORY Section 3, Chapter 336, O.S.L. 2007 (3A O.S.
2 Supp. 2007, Section 724.2), is amended to read as follows:

3 Section 724.2 A. The Oklahoma Lottery Commission shall withhold the amount of
4 delinquent debt as established by the Oklahoma Tax Commission or as established by a
5 state agency or district court seeking to collect a debt or final judgment pursuant to the
6 provisions of Section 205.2 of Title 68 of the Oklahoma Statutes from the lottery prize
7 monies won by an individual pursuant to Section 710 of ~~Title 3A of the Oklahoma~~
8 ~~Statutes~~ this title.

9 B. The Oklahoma Lottery Commission shall pay the monies withheld from the
10 lottery prize, as provided in subsection A of this section, to the ~~Oklahoma Tax~~
11 ~~Commission~~ appropriate state entity, not to exceed the amount of debt established by the
12 Oklahoma Tax Commission.

1 C. The Oklahoma Tax Commission shall promulgate rules to define the debts that
2 will be submitted to the Oklahoma Lottery Commission for withholding.

3 D. The Oklahoma Tax Commission shall develop procedures for timely notifying
4 the Oklahoma Lottery Commission of the debts that should be processed for withholding.
5 The information on debt withholding will be reported to the Oklahoma Lottery
6 Commission on a periodic basis and should include, but not be limited to:

7 1. Identification of the persons who have been determined to be delinquent in the
8 repayment of debt established by the Oklahoma Tax Commission; and

9 2. The amounts of debt to be withheld by the Oklahoma Lottery Commission.

10 E. The Oklahoma Lottery Commission shall provide a report to the Oklahoma Tax
11 Commission upon withholding that includes, but is not limited to, the following
12 information:

13 1. Identification of the persons who have had monies withheld; and

14 2. The amount of monies that will be paid to the ~~Oklahoma Tax Commission~~
15 appropriate state entity to be applied to the established debt.

16 SECTION 2. This act shall become effective November 1, 2008.
