ENGROSSED SENATE BILL NO. 1178 - By: BROWN of the Senate and PETERSON (RON) of the House.

An Act relating to public safety; amending 63 O.S. 2001, Section 4030, as last amended by Section 102, Chapter 1, O.S.L. 2005 (63 O.S. Supp. 2007, Section 4030), which relates to the Oklahoma Vessel and Motor Registration Act; requiring development of certain numbering system by the Oklahoma Tax Commission; authorizing development of certain numbering system by certain tribes; requiring conformation of certain numbers to certain regulations; providing system effective date; requiring certain recordation of permanent vessel numbers issued by certain tribes; providing specifications for placement of certain decals and numbers; providing specifications for composition of certain decals and numbers; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. AMENDATORY 63 O.S. 2001, Section 4030, as last amended by
2 Section 102, Chapter 1, O.S.L. 2005 (63 O.S. Supp. 2007, Section 4030), is amended to
3 read as follows:
4 Section 4030. A. 1. The Oklahoma Tax Commission shall, and each federally
5 recognized Indian tribe of this state may, develop and implement a permanent number
6 system for vessels which is consistent with United States Coast Guard statutes and
7 regulations. The system shall be effective upon the effective date of this act.

1 2. Except as otherwise provided by this section, every vessel on the waters of this
2 state shall display the permanent number assigned to it by the ~~Oklahoma~~ Tax
3 Commission or by a federally recognized Indian tribe of this state, which number shall
4 not be obliterated, erased, mutilated, removed or missing.

5 3. In order to ensure that:

6 a. a permanent number issued by a federally recognized Indian tribe of
7 this state conforms to federal statutory and regulatory requirements of
8 the United States Coast Guard, and

9 b. the rights prescribed in paragraph 2 of this subsection are extended to
10 every federally recognized Indian tribe of this state,

11 every vessel on the waters of this state assigned a permanent number by a federally
12 recognized Indian tribe of this state which issues permanent numbers shall be recorded
13 and maintained by the Tax Commission in the same manner as the Tax Commission
14 records and maintains the permanent number of vessels on the waters of this state which
15 are assigned by the Tax Commission.

16 B. The vessels authorized to display a number other than that required by the
17 provisions of the Oklahoma Vessel and Motor Registration Act are:

18 1. A documented vessel, provided that such vessel is currently registered, is
19 displaying both current registration decals, and the name, hailing port and official
20 federal documentation number assigned to it are displayed on the vessel according to
21 federal law or federal rules and regulations;

1 2. A vessel from a country other than the United States temporarily using the
2 waters of this state;

3 3. A vessel from another state owned by an out-of-state resident using the waters of
4 this state;

5 4. A vessel whose owner is the United States, a state or a subdivision thereof;
6 provided, however, if such vessel is used for recreational or rental purposes on the public
7 waters of this state, ~~said~~ that vessel shall display the permanent number assigned to it
8 by the Tax Commission;

9 5. A vessel that is used exclusively and solely for racing purposes;

10 6. A vessel that is used exclusively and solely as a lifeboat; and

11 7. A commercial flotation device which is assigned a permit by the ~~Oklahoma~~
12 Scenic Rivers Commission pursuant to the provisions of Sections 1461 et seq. of Title 82
13 of the Oklahoma Statutes.

14 C. Except as otherwise provided for in this section, every vessel and every outboard
15 motor on the waters of this state shall display the current registration decals or decal
16 assigned to it by the ~~Oklahoma~~ Tax Commission. The outboard motor registration decal
17 shall be affixed to the upper portion of the motor cowling in such a manner that
18 approximately one-half (1/2) of the decal is displayed on the left side of the motor cowling
19 extending toward the rear of the motor cowling. Vessel registration decals shall be:

20 1. Affixed on each side of the forward half of the vessel; and

21 2. In line with and within six (6) inches aft of the permanent number.

1 D. The owner of any vessel issued a permanent number pursuant to the provisions
2 of the Oklahoma Vessel and Motor Registration Act, Section 4002 et seq. of this title,
3 shall place on or attach to the vessel ~~said~~ the permanent number in such manner ~~as may~~
4 ~~be prescribed by the rules of the Commission, in order~~ that it may be clearly visible. The
5 permanent number shall be:

6 1. Be maintained in legible condition;

7 2. Be painted, applied as a decal, or otherwise affixed to each side of the forward
8 half of the vessel in contrasting color to the background, as high above the waterline as is
9 practical;

10 3. Read from left to right;

11 4. Be comprised of numbers and letters printed in block style of at least three (3)
12 inches in height and one-half (1/2) inch in stroke width; and

13 5. Have spaces or hyphens that are equal to the width of a letter other than "I" or a
14 number other than "1" between the letter and number groupings.

15 No other similar numbers shall be displayed on either side of the forward half of the
16 vessel.

17 E. The provisions of this section shall not apply to sailboards or fishing tubes.

18 F. The Tax Commission shall adopt rules for the placement of the registration decal
19 in an alternate location for antique boats. In this subsection, "antique boat" means a boat
20 that:

21 1. Is used primarily for recreational purposes; and

22 2. Was manufactured before 1968.

1 Such rules shall allow vessels registered as antique boats to display the registration
2 decal on the left portion of the windshield. In the absence of a windshield, the rules shall
3 allow operators of antique boats to attach the registration decal to the certificate of
4 registration and make such decal and certificate available for inspection when the boat is
5 operated on public water.

6 SECTION 2. This act shall become effective November 1, 2008.
