COMMITTEE SUBSTITUTE FOR ENGROSSED SENATE BILL NO. 1422 - By:
PADDACK of the Senate and STEELE, SHELTON, HILLIARD, MCCULLOUGH,
MCDANIEL (JEANNIE) AND PITTMAN of the House.

An Act relating to mental health; directing the Department of Mental Health and Substance Abuse Services to develop and implement a mental health first aid pilot program; stating purpose of program; setting curriculum requirements; providing for a certificate in mental health first aid upon completion of certain training; authorizing the Department to enter into certain contract; requiring certain report; directing the Board of Mental Health and Substance Abuse Services to promulgate rules; providing for codification; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma
2 Statutes as Section 13-101 of Title 43A, unless there is created a duplication in
3 numbering, reads as follows:

4 A. The Department of Mental Health and Substance Abuse Services shall develop
5 and implement a mental health first aid pilot program. The purpose of the mental
6 health first aid pilot program shall be to train non-mental-health professionals in how to
7 support an individual in a mental health crisis situation until professional help can be
8 obtained.

1 B. The Department shall adopt a curriculum which, at a minimum, shall include
2 training for individuals on the symptoms, causes and evidence-based treatments for
3 common mental health problems, including, but not limited to, depression, anxiety
4 disorders, psychosis, and substance abuse disorders. The curriculum shall also address
5 possible crisis situations arising from these mental health problems and steps to support
6 an individual in a crisis situation.

7 C. The Department shall issue a certificate in mental health first aid to individuals
8 who complete the course of training. The Department shall establish criteria for
9 certification.

10 D. The Department is authorized to enter into a contract to implement the
11 provisions of this section.

12 E. On or before December 31, 2009, and annually thereafter, the Department shall
13 submit a report to the Legislature stating the number of participants in the program, the
14 number of individuals who received a certificate in the program, and any
15 recommendations for improvement of the program.

16 F. The Board of Mental Health and Substance Abuse Services shall promulgate
17 rules as necessary to implement the provisions of this section.

18 SECTION 2. This act shall become effective November 1, 2008.
