House Bill No. 2822

HOUSE BILL NO. 2822 - By: SULLIVAN AND SHERRER of the House and JOLLEY of the Senate.

An Act relating to public health and safety; amending Section 1, Chapter 309, O.S.L. 2003 (63 O.S. Supp. 2007, Section 2815.1), which relates to outgoing emergency telephone calls; deleting certain population restriction; making nine-one-one emergency telephone service information confidential; limiting liability of certain persons providing nine-one-one emergency telephone service information; amending 63 O.S. 2001, Section 2817, which relates to liability for providing nine-one-one emergency telephone service; modifying application to public bodies; expanding liability restrictions; providing definitions of certain terms; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. AMENDATORY Section 1, Chapter 309, O.S.L. 2003 (63 O.S.
2 Supp. 2007, Section 2815.1), is amended to read as follows:

3 Section 2815.1 A. Nine-one-one emergency telephone service information may be
4 used by a public law enforcement or public health agency ~~in a city having a population of~~
5 ~~more than three hundred thousand (300,000) according to the latest Federal Decennial~~
6 ~~Census~~ for the purpose of placing outgoing emergency calls that notify the public of an
7 emergency or provide to the public information relative to an emergency.

8 B. Nine-one-one emergency telephone service information shall be confidential.

9 Any public law enforcement or public health agency ~~in a city having a population of more~~
10 ~~than three hundred thousand (300,000) according to the latest Federal Decennial Census~~

1 that uses nine-one-one emergency telephone service information for the purposes set
2 forth in subsection A of this section shall establish methods and procedures that ensure
3 the confidentiality of the information.

4 C. For purposes of this section “nine-one-one emergency telephone service
5 information” shall mean the name, address and telephone number of a service user of a
6 local exchange telephone company.

7 D. No person providing service pursuant to this section shall be liable for using
8 nine-one-one emergency telephone service information in accordance with subsection B of
9 this section.

10 SECTION 2. AMENDATORY 63 O.S. 2001, Section 2817, is amended to read
11 as follows:

12 Section 2817. A. No public body or employee of a public agency or public agency
13 ~~acting under the provisions of Section 2811 et seq. of this title~~ body shall be liable for the
14 method of providing or failure to provide nine-one-one emergency telephone or
15 communication service or nine-one-one wireless emergency telephone service or for the
16 method of providing or failure to provide emergency response service ~~except as otherwise~~
17 ~~provided under the Governmental Tort Claims Act, nor shall such person or.~~

18 B. No public agency body or employee of a public body shall have any special duty
19 to any service user or other user of the nine-one-one emergency telephone system or nine-
20 one-one wireless emergency telephone system or any other telecommunication or
21 information system supplying or obligated to supply nine-one-one service.

1 ~~B. C.~~ A service provider of telecommunications or other communication services
2 involved in providing nine-one-one emergency ~~telephone~~ service or nine-one-one wireless
3 emergency telephone service shall not be liable for any claim, damage, or loss arising
4 from the provision of nine-one-one emergency telephone service or nine-one-one wireless
5 emergency telephone service unless the act or omission proximately causing the claim,
6 damage, or loss constitutes gross negligence, recklessness, or intentional misconduct.

7 D. As used in this section, “public body” shall have the meaning as defined in
8 Section 304 of Title 25 of the Oklahoma Statutes and “employee” shall have the meaning
9 as defined in Section 152 of Title 51 of the Oklahoma Statutes.

10 SECTION 3. It being immediately necessary for the preservation of the public
11 peace, health and safety, an emergency is hereby declared to exist, by reason whereof
12 this act shall take effect and be in full force from and after its passage and approval.
