13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. There is hereby appropriated to the Oklahoma
15 Educational Television Authority from any monies not otherwise
16 appropriated from the General Revenue Fund of the State Treasury for
17 the fiscal year ending June 30, 2009, the sum of _____
18 Dollars (\$0.00) or so much thereof as may be necessary to perform
19 the duties imposed upon the Oklahoma Educational Television
20 Authority by law.

21 SECTION 2. For the fiscal year ending June 30, 2009, the
22 Oklahoma Educational Television Authority shall budget all funds in
23 the following categories and amounts:

5 The Authority shall develop outcome-based performance measures
6 for each budget category.

7 SECTION 3. The duties and compensation of employees, not
8 otherwise prescribed by law, necessary to perform the duties imposed
9 upon the Oklahoma Educational Television Authority by law shall be
10 set by the Director. The salary of the Director shall not exceed
11 _____ Dollars (\$0.00) per annum, payable monthly for
12 the fiscal year ending June 30, 2009. The Oklahoma Educational
13 Television Authority for the fiscal year ending June 30, 2009, shall
14 be subject to the following budgetary limitations on full-time-
15 equivalent employees and expenditures excluding expenditures for
16 capitol and special projects except as may be authorized pursuant to
17 the provisions of Section 3603 of Title 74 of the Oklahoma Statutes:
