13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. There is hereby appropriated to the Physician
15 Manpower Training Commission from any monies not otherwise
16 appropriated from the General Revenue Fund of the State Treasury for
17 the fiscal year ending June 30, 2009, the sum of _____
18 Dollars (\$0.00) or so much thereof as may be necessary to perform
19 the duties imposed upon the Physician Manpower Training Commission
20 by law.

21 SECTION 2. For the fiscal year ending June 30, 2009, the
22 Physician Manpower Training Commission shall budget all funds in the
23 following categories and amounts:

14 by the Physician Manpower Training Commission. The salary of the
15 Executive Director shall not exceed _____Dollars (\$0.00)
16 per annum, payable monthly for the fiscal year ending June 30, 2009.
17 The Physician Manpower Training Commission for the fiscal year
18 ending June 30, 2009, shall be subject to the following budgetary
19 limitations on full-time-equivalent employees and expenditures
20 excluding expenditures for capital and special projects, except as
21 may be authorized pursuant to the provisions of Section 3603 of
22 Title 74 of the Oklahoma Statutes:
