5 ENGROSSED HOUSE BILL NO. 3198 - By: Denney of the House and Jolley
6 of the Senate.

7 An Act relating to arts and culture; creating the Task Force
8 on Creative Artist Guilds; stating purpose of the Task
9 Force; providing for membership; providing for appointments,
10 meetings, officers, travel reimbursements, and staffing;
11 stating duties of the Task Force; requiring a report by
12 certain date; providing for noncodification; and declaring
13 an emergency.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. NEW LAW A new section of law not to be
16 codified in the Oklahoma Statutes reads as follows:

17 A. There is hereby created to continue until July 1, 2009, the
18 Task Force on Creative Artist Guilds. The purpose of the Task Force
19 shall be to study the various approaches to organizing,
20 establishing, and supporting creative artist guilds in the state,
21 the goal being to provide a cooperative structure for artists and
22 creative individuals who reside in the state and who can advance the
23 visual and performing arts in the state through education,
24 exhibitions, and workshops.

25 B. The Task Force shall consist of the following members:

26 1. One member of the Oklahoma House of Representatives,
27 appointed by the Speaker of the Oklahoma House of Representatives;

1 2. One member of the State Senate, appointed by the President
2 Pro Tempore of the State Senate;

3 3. One member who represents a statewide nonprofit arts
4 organization, appointed by the Governor;

5 4. Two members who are artists or who are employed in an art or
6 creative industries field or area, one to be appointed by the
7 Speaker of the House of Representatives and one to be appointed by
8 the President Pro Tempore of the Senate;

9 5. Two members who represent local arts organizations, one to
10 be appointed by the Speaker of the House of Representatives and one
11 to be appointed by the President Pro Tempore of the Senate;

12 6. The Director of the Oklahoma Office of the Film and Music
13 Commission; and

14 7. The Executive Director of the Oklahoma Arts Council.

15 C. Members of the Task Force shall be appointed no later than
16 September 1, 2008. The first meeting of the Task Force shall be
17 called by the Executive Director of the Oklahoma Arts Council.
18 Subsequent meetings shall be held at the call of the chair or vice-
19 chair. The chair and vice-chair of the Task Force shall be elected
20 by the members at the first meeting of the Task Force.

21 D. Members of the Task Force shall receive no compensation but
22 shall receive travel reimbursement as follows:

1 1. Legislative members shall be reimbursed for their necessary
2 travel expenses incurred in the performance of their duties in
3 accordance with Section 456 of Title 74 of the Oklahoma Statutes;
4 and

5 2. Nonlegislative members shall be reimbursed by their
6 respective agencies or appointing authority for their necessary
7 travel expenses in the performance of their duties in accordance
8 with the State Travel Reimbursement Act.

9 E. Staffing for the Task Force shall be performed by the staff
10 of the Oklahoma House of Representatives and the State Senate.

11 F. The Task Force shall study the following issues and make a
12 report of its findings and any recommendations to the Governor,
13 Speaker of the Oklahoma House of Representatives, and the President
14 Pro Tempore of the State Senate by February 1, 2009:

15 1. Study various approaches to organizing a creative artist
16 guild;

17 2. Study the organizational structure of creative artist guilds
18 in other states;

19 3. Make recommendations on funding support and other resources
20 that can be provided to creative artist guilds; and

21 4. Study the cultural, educational, and economic impact that
22 creative artist guilds can have on the state.

1 SECTION 2. It being immediately necessary for the preservation
2 of the public peace, health and safety, an emergency is hereby
3 declared to exist, by reason whereof this act shall take effect and
4 be in full force from and after its passage and approval.
