4 SENATE BILL NO. 1841 - By: ALDRIDGE of the Senate and WRIGHT of the  
5 House.

6 An Act relating to sunset; amending 74 O.S. 2001, Sections  
7 3903, as amended by Section 1, Chapter 331, O.S.L. 2002, and  
8 3917, as amended by Section 3, Chapter 24, O.S.L. 2005 (74  
9 O.S. Supp. 2007, Sections 3903 and 3917), which relate to  
10 the Oklahoma Sunset Law; deleting certain entity; sunsetting  
11 the Special Agency Account Board; recreating certain  
12 entities; and modifying allowable termination date.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY 74 O.S. 2001, Section 3903, as  
15 amended by Section 1, Chapter 331, O.S.L. 2002 (74 O.S. Supp. 2007,  
16 Section 3903), is amended to read as follows:

17 Section 3903. The following statutory entities and their  
18 successors shall be terminated on July 1, ~~2008~~ 2012, and all powers,  
19 duties and functions shall be abolished one (1) year thereafter:

20 1. Oklahoma State Committee of Plumbing Examiners as created by  
21 Section 1004 of Title 59 of the Oklahoma Statutes;

22 2. Waterworks and Wastewater Works Advisory Council as created  
23 by Section 1103 of Title 59 of the Oklahoma Statutes;

24 ~~3. Special Agency Account Board as created by Section 7.2 of~~  
25 ~~Title 62 of the Oklahoma Statutes;~~

26 ~~4. 3.~~ State Board of Examiners of Certified Shorthand Reporters  
27 as created by Section 1501 of Title 20 of the Oklahoma Statutes;

1       ~~5.~~ 4. Oklahoma EMS Advisory Council as created by Section 1-  
2 2516 of Title 63 of the Oklahoma Statutes;

3       ~~6. Advisory Council on Alcohol and Drug Abuse as created by~~  
4 ~~Section 3 407 of Title 43A of the Oklahoma Statutes; and~~

5       ~~7.~~ 5. Oklahoma Educational Television Authority as created by  
6 Section 23-105 of Title 70 of the Oklahoma Statutes;

8 104 of Title 11 of the Oklahoma Statutes; and

9       7. State Board of Examiners of Perfusionists as created by  
10 Section 2053 of Title 59 of the Oklahoma Statutes.

11       SECTION 2.        AMENDATORY        74 O.S. 2001, Section 3917, as  
12 amended by Section 3, Chapter 24, O.S.L. 2005 (74 O.S. Supp. 2007,  
13 Section 3917), is amended to read as follows:

14       Section 3917. A. Any statutory entity enumerated in the  
15 Oklahoma Sunset Law shall, if re-created, be placed in this act to  
16 be terminated or re-created not more than ~~six (6)~~ four (4) years  
17 thereafter.

18       B. The Oklahoma Department of Libraries shall monitor actions  
19 of the State Legislature and maintain a list of all agencies,  
20 boards, commissions, committees or other entities created or  
21 authorized by law, and all entities created by a Governor's  
22 Executive Order. The updated list shall be provided to the  
23 Governor, the President Pro Tempore of the Oklahoma Senate, the

1 Speaker of the Oklahoma House of Representatives, and the chairs of  
2 the appropriate House or Senate sunset committee within thirty (30)  
3 days after sine die adjournment of each legislative session.
