10 An Act relating to general appropriations for the
11 expenses of various agencies of the executive,
12 legislative and judicial departments of the state;
13 making appropriations to the State Board of
14 Education, the Commissioners of the Land Office, the

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 SECTION 1. There is hereby appropriated to the State Board of
3 Education from any monies not otherwise appropriated from the
4 General Revenue Fund of the State Treasury for the fiscal year
5 ending June 30, 2008, the sum of _____ Dollars (\$0.00) or so
6 much thereof as may be necessary for the financial support of public
7 schools.

8 SECTION 2. The State Board of Education is hereby authorized to
9 expend during the fiscal year ending June 30, 2008, from the
10 Education Reform Revolving Fund created in Section 41.29b of Title
11 62 of the Oklahoma Statutes, the sum of _____ Dollars (\$0.00)
12 or so much thereof as may be necessary for the financial support of
13 public schools.

14 SECTION 3. There is hereby appropriated to the State Board of
15 Education from the Oklahoma Education Lottery Trust Fund of the
16 State Treasury for the fiscal year ending June 30, 2008, the sum of
17 _____ Dollars (\$0.00) or so much thereof as may be necessary for
18 certified employee salary increases for the fiscal year ending June
19 30, 2008, in the support of public school activities.

20 SECTION 4. There is hereby appropriated to the State Board of
21 Education from any monies not otherwise appropriated from the
22 Mineral Leasing Fund of the State Treasury for the fiscal year
23 ending June 30, 2008, the sum of _____ Dollars (\$0.00) or so
24

1 much thereof as may be necessary for the financial support of public
2 schools.

3 SECTION 5. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Mineral Leasing Fund of the State Treasury for the fiscal year
6 ending June 30, 2006, the sum of _____ Dollars (\$0.00) or so
7 much thereof as may be necessary for the financial support of public
8 schools.

9 SECTION 6. The State Board of Education is hereby authorized to
10 expend during the fiscal year ending June 30, 2008, from the Common
11 Education Technology Revolving Fund of the State Treasury, the sum
12 of _____ Dollars (\$0.00) or so much thereof as may be necessary
13 for the financial support of public schools.

14 SECTION 7. There is hereby appropriated to the State Board of
15 Education from any monies not otherwise appropriated from the
16 Oklahoma Education Lottery Trust Fund of the State Treasury for the
17 fiscal year ending June 30, 2008, the sum of _____ Dollars
18 (\$0.00) or so much thereof as may be necessary for transfer to the
19 School Consolidation Assistance Fund.

20 SECTION 8. There is hereby appropriated to the State Board of
21 Education from any monies not otherwise appropriated from the
22 Oklahoma Education Lottery Trust Fund of the State Treasury for the
23 fiscal year ending June 30, 2008, the sum of _____ Dollars
24

1 (\$0.00) or so much thereof as may be necessary for transfer to the
2 Teachers' Retirement System Dedicated Revenue Revolving Fund.

3 SECTION 9. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 General Revenue Fund of the State Treasury for the fiscal year
6 ending June 30, 2008, the sum of _____ Dollars (\$0.00) or so
7 much thereof as may be necessary for the support of public school
8 activities.

9 SECTION 10. There is hereby appropriated to the State Board of
10 Education from any monies not otherwise appropriated from the
11 General Revenue Fund of the State Treasury for the fiscal year
12 ending June 30, 2008, the sum of _____ Dollars (\$0.00) or so
13 much thereof as may be necessary for the purchase of textbooks.

14 SECTION 11. There is hereby appropriated to the State Board of
15 Education from any monies not otherwise appropriated from the
16 General Revenue Fund of the State Treasury for the fiscal year
17 ending June 30, 2008, the sum of _____ Dollars (\$0.00) or so
18 much thereof as may be necessary for Administrative and Support
19 Functions of the State Department of Education.

20 SECTION 12. There is hereby appropriated to the State Board of
21 Education from any monies not otherwise appropriated from the
22 General Revenue Fund of the State Treasury for the fiscal year
23 ending June 30, 2008, the sum of _____ Dollars (\$0.00) or so
24

1 much thereof as may be necessary for the Certified Employee Health
2 Benefit Allowance.

3 SECTION 13. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 General Revenue Fund of the State Treasury for the fiscal year
6 ending June 30, 2008, the sum of _____ Dollars (\$0.00) or so
7 much thereof as may be necessary for the Support Personnel Health
8 Benefit Allowance.

9 SECTION 14. There is hereby appropriated to the Commissioners
10 of the Land Office from any monies not otherwise appropriated from
11 the Commissioners of the Land Office Fund of the State Treasury for
12 the fiscal year ending June 30, 2008, the sum of _____ Dollars
13 (\$0.00) or so much thereof as may be necessary to perform the duties
14 imposed upon the Commissioners of the Land Office by law.

15 SECTION 15. There is hereby appropriated to the Board of
16 Trustees of the Oklahoma School of Science and Mathematics from any
17 monies not otherwise appropriated from the General Revenue Fund of
18 the State Treasury for the fiscal year ending June 30, 2008, the sum
19 of _____ Dollars (\$0.00) or so much thereof as may be necessary
20 to perform the duties imposed upon the Board of Trustees of the
21 Oklahoma School of Science and Mathematics by law.

22 SECTION 16. There is hereby appropriated to the Oklahoma
23 Commission for Teacher Preparation from any monies not otherwise
24 appropriated from the General Revenue Fund of the State Treasury for

1 the fiscal year ending June 30, 2008, the sum of _____ Dollars
2 (\$0.00) or so much thereof as may be necessary to perform the duties
3 imposed upon the Oklahoma Commission for Teacher Preparation by law.

4 SECTION 17. There is hereby appropriated to the State Board of
5 Career and Technology Education from any monies not otherwise
6 appropriated from the General Revenue Fund of the State Treasury for
7 the fiscal year ending June 30, 2008, the sum of _____ Dollars
8 (\$0.00) or so much thereof as may be necessary to perform the duties
9 imposed upon the State Board of Career and Technology Education by
10 law.

11 SECTION 18. There is hereby appropriated to the State Board of

21 (\$0.00) or so much thereof as may be necessary for the Support
22 Personnel Health Benefit Allowance.

23 SECTION 20. There is hereby appropriated to the Oklahoma State
24 Regents for Higher Education from any monies not otherwise

2 the fiscal year ending June 30, 2008, the sum of _____ Dollars
3 (\$0.00) or so much thereof as may be necessary for allocation by the
4 Oklahoma State Regents for Higher Education pursuant to the
5 provisions of Article XIII-A of the Oklahoma Constitution for the
6 education and general operating budgets of the institutions and for
7 other programs, construction, renovations or repairs administered by
8 the Oklahoma State Regents for Higher Education.

9 SECTION 21. The Oklahoma State Regents for Higher Education are
10 hereby authorized to expend during the fiscal year ending June 30,
11 2008, the sum of _____ Dollars (\$0.00) from the Higher
12 Education Capital Revolving Fund of the State Treasury for
13 allocation by the Oklahoma State Regents for Higher Education
14 pursuant to the provisions of Article XIII-A of the Oklahoma
15 Constitution for the education and general operating budgets of the
16 institutions and for other programs, construction, renovations or
17 repairs administered by the Oklahoma State Regents for Higher
18 Education.

19 SECTION 22. The Oklahoma State Regents for Higher Education are
20 hereby authorized to expend during the fiscal year ending June 30,
21 2008, the sum of _____ Dollars (\$0.00) from the Oklahoma
22 Tuition Scholarship Revolving Fund of the State Treasury for
23 allocation by the Oklahoma State Regents for Higher Education
24 pursuant to the provisions of Article XIII-A of the Oklahoma

1 Constitution for the education and general operating budgets of the
2 institutions and for other programs, construction, renovations or
3 repairs administered by the Oklahoma State Regents for Higher
4 Education.

5 SECTION 23. There is hereby appropriated to the Oklahoma State
6 Regents for Higher Education from any monies not otherwise
7 appropriated from the Oklahoma Education Lottery Trust Fund of the
8 State Treasury for the fiscal year ending June 30, 2008, the sum of
9 _____ Dollars (\$0.00) pursuant to paragraph 2 of subsection C of
10 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
11 the Oklahoma State Regents for Higher Education pursuant to the
12 provisions of Article XIII-A of the Oklahoma Constitution for the
13 education and general operating budgets of the institutions and for
14 other programs, construction, renovations or repairs administered by
15 the Oklahoma State Regents for Higher Education.

16 SECTION 24. There is hereby appropriated to the Oklahoma State
17 Regents for Higher Education from any monies not otherwise
18 appropriated from the General Revenue Fund of the State Treasury for
19 the fiscal year ending June 30, 2008, the sum of _____ Dollars
20 (\$0.00) or so much thereof as may be necessary for the general
21 operating budget of the Administrative Offices of the Oklahoma State
22 Regents for Higher Education.

23 SECTION 25. There is hereby appropriated to the Oklahoma State
24 Regents for Higher Education from any monies not otherwise

1 appropriated from the Special Cash Fund of the State Treasury, the
2 sum of _____ Dollars (\$0.00) or so much thereof as may be
3 necessary for allocation by the Oklahoma State Regents for Higher
4 Education pursuant to the provisions of Article XIII-A of the
5 Oklahoma Constitution for the education and general operation
6 budgets of the institutions and for other programs, construction,
7 renovations or repairs administered by the Oklahoma State Regents
8 for Higher Education.

9 SECTION 26. There is hereby appropriated to the Oklahoma State
10 Regents for Higher Education from any monies not otherwise
11 appropriated from the Special Cash Fund of the State Treasury, the
12 sum of _____ Dollars (\$0.00) or so much thereof as may be
13 necessary for expenditures in the endowed chairs program.

14 SECTION 27. There is hereby appropriated to the Oklahoma State
15 Regents for Higher Education from any monies not otherwise
16 appropriated from the General Revenue Fund of the State Treasury for
17 the fiscal year ending June 30, 2008, the sum of _____ Dollars
18 (\$0.00) or so much thereof as may be necessary to perform the duties
19 imposed upon the Office of Accountability by law.

20 SECTION 28. There is hereby appropriated to the Physician
21 Manpower Training Commission from any monies not otherwise
22 appropriated from the General Revenue Fund of the State Treasury for
23 the fiscal year ending June 30, 2008, the sum of _____ Dollars

1 (\$0.00) or so much thereof as may be necessary to perform the duties
2 imposed upon the Physician Manpower Training Commission by law.

3 SECTION 29. There is hereby appropriated to the Oklahoma Board

16 SECTION 31. There is hereby appropriated to the Oklahoma
17 Capitol Complex and Centennial Commemoration Commission from any
18 monies not otherwise appropriated from the General Revenue Fund of
19 the State Treasury for the fiscal year ending June 30, 2008, the sum
20 of _____ Dollars (\$0.00) or so much thereof as may be
21 necessary to perform the duties imposed upon the Oklahoma Capitol
22 Complex and Centennial Commemoration Commission by law.

23 SECTION 32. There is hereby appropriated to the Oklahoma

8 of Title 21 of the Oklahoma Statutes to the District Attorneys
9 Council for eight (8) employees, including related duties to support
10 the Crime Victims Compensation Board.

11 SECTION 45. For the fiscal year ending June 30, 2008, up to
