1 The bridge across Salt Creek, currently known as the "salt
2 creek" bridge, located on State Highway 31 south of Ashland,
3 Oklahoma, shall be designated as the "PFC 1st Class Glen W. Page
4 Bridge". The Department of Transportation shall cause suitable
5 permanent markers to be placed upon the bridge bearing that name.

6 SECTION 3. NEW LAW A new section of law to be codified
7 in the Oklahoma Statutes as Section 1698.20 of Title 69, unless
8 there is created a duplication in numbering, reads as follows:

9 The bridge located where State Highway 31 crosses Keel Creek
10 northeast of Coalgate, Oklahoma, and near Cairo, Oklahoma, shall be
11 designated as the "Pvt. Everett C. (Bud) Ward Bridge". The
12 Department of Transportation shall cause suitable permanent markers
13 to be placed upon the bridge bearing that name.

14 SECTION 4. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 1698.21 of Title 69, unless
16 there is created a duplication in numbering, reads as follows:

17 The bridge located where State Highway 97 crosses the Arkansas
18 River in Sand Springs, Oklahoma, shall be designated as the "OHP Lt.
19 Pat Grimes Bridge". The Department of Transportation shall cause
20 suitable permanent markers to be placed upon the bridge bearing that
21 name.

22 SECTION 5. This act shall become effective November 1, 2008.
