6 AS INTRODUCED

7 An Act relating to amusements and sports; amending  
8 Section 3, Chapter 336, O.S.L. 2007 (3A O.S. Supp.  
9 2007, Section 724.2), which relates to the lottery;  
10 transferring certain responsibilities from the  
11 Oklahoma Tax Commission to the Oklahoma Department of  
12 Transportation; and providing an effective date.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY Section 3, Chapter 336, O.S.L.  
14 2007 (3A O.S. Supp. 2007, Section 724.2), is amended to read as  
15 follows:

16 Section 724.2 A. The Oklahoma Lottery Commission shall  
17 withhold the amount of delinquent debt as established by the  
18 Oklahoma ~~Tax Commission~~ Department of Transportation from the  
19 lottery prize monies won by an individual pursuant to Section 710 of  
20 ~~Title 3A of the Oklahoma Statutes~~ this title.

21 B. The Oklahoma Lottery Commission shall pay the monies  
22 withheld from the lottery prize, as provided in subsection A of this  
23 section, to the Oklahoma ~~Tax Commission~~ Department of

1 Transportation, not to exceed the amount of debt established by the  
2 Oklahoma ~~Tax Commission~~ Department of Transportation.

3 C. The Oklahoma ~~Tax Commission~~ Department of Transportation  
4 shall promulgate rules to define the debts that will be submitted to  
5 the Oklahoma Lottery Commission for withholding.

6 D. The Oklahoma ~~Tax Commission~~ Department of Transportation  
7 shall develop procedures for timely notifying the Oklahoma Lottery  
8 Commission of the debts that should be processed for withholding.  
9 The information on debt withholding will be reported to the Oklahoma  
10 Lottery Commission on a periodic basis and should include, but not  
11 be limited to:

12 1. Identification of the persons who have been determined to be  
13 delinquent in the repayment of debt established by the Oklahoma ~~Tax~~  
14 ~~Commission~~ Department of Transportation; and

15 2. The amounts of debt to be withheld by the Oklahoma Lottery  
16 Commission.

17 E. The Oklahoma Lottery Commission shall provide a report to  
18 the Oklahoma ~~Tax Commission~~ Department of Transportation upon  
19 withholding that includes, but is not limited to, the following  
20 information:

21 1. Identification of the persons who have had monies withheld;

1           2. The amount of monies that will be paid to the Oklahoma ~~Tax~~  
2 ~~Commission~~ Department of Transportation to be applied to the  
3 established debt.

4           SECTION 2. This act shall become effective November 1, 2008.
