6 AS INTRODUCED

7 A Joint Resolution directing the Secretary of State  
8 to refer to the people for their approval or  
9 rejection a proposed amendment to Section 35 of  
10 Article IX of the Constitution of the State of  
11 Oklahoma, which relates to the Corporation  
12 Commission; clarifying language; providing ballot  
13 title; and directing filing.

14 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF THE  
15 2ND SESSION OF THE 51ST OKLAHOMA LEGISLATURE:

16 SECTION 1. The Secretary of State shall refer to the people for  
17 their approval or rejection, as and in the manner provided by law,  
18 the following proposed amendment to Section 35 of Article IX of the  
19 Constitution of the State of Oklahoma to read as follows:

20 Section 35. After the second Monday in January, nineteen  
21 hundred and nine, the Legislature may, by law, from time to time,  
22 alter, amend, revise, or repeal one or more sections from eighteen  
23 to thirty-four, inclusive, of this article, ~~or any of them,~~ or any  
24 amendments thereof: ~~Provided, That;~~ provided, no amendment made

1 under authority of this section shall contravene the provisions of  
2 any part of this Constitution other than the ~~said~~ sections ~~last~~  
3 ~~above~~ referred to in this section or any such amendments ~~thereof~~  
4 thereto.

5 SECTION 2. The Ballot Title for the proposed Constitutional  
6 amendment as set forth in SECTION 1 of this resolution shall be in  
7 the following form:

9 Legislative Referendum No. \_\_\_\_\_ State Question No. \_\_\_\_\_

10 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

11 This measure amends the Oklahoma Constitution. It amends  
12 Section 35 of Article 9. The section lets the Legislature amend  
13 some sections of the Constitution. The amendment clarifies  
14 language.

15 SHALL THE PROPOSAL BE APPROVED?

18 SECTION 3. The Chief Clerk of the House of Representatives,  
19 immediately after the passage of this resolution, shall prepare and

22 Attorney General.
