6 AS INTRODUCED

7 An Act relating to elections; amending 26 O.S. 2001,
8 Section 2-118, as last amended by Section 1, Chapter
9 83, 2nd Extraordinary Session, O.S.L. 2006 (26 O.S.
10 Supp. 2007, Section 2-118), which relates to salaries
of county election board secretaries; deleting
11 obsolete language; modifying salaries; providing an
12 effective date; and declaring an emergency.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY 26 O.S. 2001, Section 2-118, as
15 last amended by Section 1, Chapter 83, 2nd Extraordinary Session,
16 O.S.L. 2006 (26 O.S. Supp. 2007, Section 2-118), is amended to read
17 as follows:

18 Section 2-118. A. The secretary of each county election board
19 shall be paid an annual salary to be determined by the following
20 schedule. However, the salary of a county election board secretary
21 shall not fall below the level of the April 30, 2003, salary, and
22 the salary of any person who is reappointed to the position of
23 county election board secretary shall not fall below the salary
24 received in the immediately preceding term, regardless of the number

1 of active registered voters in the county. A county election board
2 secretary serving on April 30, 2004, shall not receive a salary
3 increase if said secretary is paid an amount greater than the salary
4 indicated in this section according to the number of registered
5 voters in said county. A county election board secretary shall not
6 receive a salary increase while the county is under the
7 administrative supervision of the State Election Board.

17 B. The salary and fringe benefits paid to each secretary shall
18 be paid from county funds on a monthly basis and shall be reimbursed
19 from funds appropriated by the Legislature for that purpose at a
20 rate of not to exceed one hundred thirty-five percent (135%) of the
21 above-specified salaries. Claims for said reimbursement shall be
22 filed according to procedures prescribed by the Secretary of the
23 State Election Board and approved by the Director of State Finance.
24 Said claims for reimbursement shall only be paid for actual

1 expenditures made by the county. The number of registered voters,
2 for the purposes of this section, shall be determined by the number
3 of registered voters, excluding inactive voters, in the county on
4 January 1, 1979, and every two (2) years thereafter.

5 SECTION 2. This act shall become effective July 1, 2008.

6 SECTION 3. It being immediately necessary for the preservation
7 of the public peace, health and safety, an emergency is hereby
8 declared to exist, by reason whereof this act shall take effect and
9 be in full force from and after its passage and approval.
