10 AS INTRODUCED

11 An Act relating to the Corporation Commission;
12 requiring budgeting in certain categories and
13 amounts; requiring certain performance measures;
14 providing for duties and compensation of employees;
15 limiting salary of the General Administrator;
16 providing budgetary limitations; and providing an
17 effective date.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. For the fiscal year ending June 30, 2009, the
20 Corporation Commission shall budget all funds in the following
21 categories and amounts:

9 The agency shall develop outcome-based performance measures for
10 each budget category.

11 SECTION 2. The duties and compensation of employees, not
12 otherwise prescribed by law, necessary to perform the duties imposed
13 upon the Corporation Commission by law shall be set by the General
14 Administrator. The salary of the General Administrator of the
15 Corporation Commission shall not exceed _____ Dollars (\$0.00)
16 per annum, payable monthly for the fiscal year ending June 30, 2009.
17 The Corporation Commission shall be subject to the following
18 budgetary limitations on full-time-equivalent employees and
19 expenditures excluding direct expenditures for well plugging as
20 authorized in Section 310 of Title 52 of the Oklahoma Statutes, pit
21 closure as authorized in Section 140 of Title 52 of the Oklahoma
22 Statutes, and remediation of sites as authorized in Section 353 of
23 Title 17 of the Oklahoma Statutes, and as may be authorized pursuant

1 to the provisions of Section 3603 of Title 74 of the Oklahoma
2 Statutes:
