9 AS INTRODUCED

10 An Act relating to the Oklahoma Historical Society;
11 making an appropriation; stating purpose; requiring
12 budgeting in certain categories and amounts;
13 requiring certain performance measures; providing for
14 duties and compensation of employees; limiting salary
of Executive Director and Deputy Executive Director;
providing budgetary limitations; and providing an
effective date.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. There is hereby appropriated to the Oklahoma
19 Historical Society from any monies not otherwise appropriated from
20 the General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2009, the sum of _____ Dollars (\$0.00) or
22 so much thereof as may be necessary to perform the duties imposed
23 upon the Oklahoma Historical Society by law.

1 SECTION 2. For the fiscal year ending June 30, 2009, the
2 Oklahoma Historical Society shall budget all funds in the following
3 categories and amounts:

11 The agency shall develop outcome-based performance measures for
12 each budget category.

13 SECTION 3. The duties and compensation of employees, not
14 otherwise prescribed by law, necessary to perform the duties imposed
15 upon the Oklahoma Historical Society by law shall be set by the
16 Executive Director of the Oklahoma Historical Society. The salary
17 of the Executive Director of the Oklahoma Historical Society shall
18 not exceed _____ Dollars (\$0.00) per annum and the salary of the
19 Deputy Executive Director of the Oklahoma Historical Society shall
20 not exceed _____ Dollars (\$0.00) per annum, payable monthly for
21 the fiscal year ending June 30, 2009. The Oklahoma Historical
22 Society for the fiscal year ending June 30, 2009, shall be subject
23 to the following budgetary limitations on full-time-equivalent
24 employees and expenditures excluding expenditures for capital and

1 special projects, except as may be authorized pursuant to the
2 provisions of Section 3603 of Title 74 of the Oklahoma Statutes:
