7 A Resolution commending Chastity Anderson upon her

13 graduated from Mounds High School in 1993; and

14 WHEREAS, Chastity Anderson and her husband, Greg, have one
15 child, a daughter, Morgan, who is six years old; and

16 WHEREAS, Chastity Anderson has worked for over 13 years in the
17 banking industry and is presently Assistant Vice
18 President/Operations Manager for Bank of Oklahoma, managing the
19 fraud department; and

20 WHEREAS, Chastity Anderson was diagnosed with Lupus more than
21 three years ago. She is now a Certified Facilitator with the Lupus
22 Foundation of America, Oklahoma Chapter, where she leads a support
23 group and will be assisting in fund-raising; and

2 held June 24 at Rogers State University in Claremore, Oklahoma.
3 Selected as Mrs. Oklahoma 2006, she competed in the Mrs. America

7 opportunity to promote Lupus awareness. She also serves as Board
8 Member and Cochair of Prom Angel Charity, which assists teens with
9 economic hardships obtain free prom dresses, shoes and other

11 Counselor for almost ten years. She owns and operates her own hobby
12 business in photography.
