15 AMENDMENT NO. 1. Strike the stricken title, enacting clause and
16 entire bill and insert

17 "An Act relating to schools; creating the School
18 District Transparency Act; providing short title;
19 requiring State Department of Education to develop
20 and make available certain information on website;
21 prohibiting charging of fees for access; specifying
22 certain information to be made available; stating
23 deadlines; providing certain exclusion from
24 disclosure; prohibiting certain liability resulting
from disclosed information; providing for
codification; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 5-135.4 of Title 70, unless
3 there is created a duplication in numbering, reads as follows:

4 A. This act shall be known and may be cited as the "School
5 District Transparency Act".

6 B. By January 30, 2011, the State Department of Education shall
7 develop and make available on its website a searchable database of
8 school district expenditures by Oklahoma Cost Accounting System
9 (OCAS) code designation. The database shall be accessible by the
10 public without any fee or charge for access. The database shall
11 provide information on school district expenditures of state,
12 federal, and local funds, whether appropriated or nonappropriated,
13 excluding payments of voluntary payroll deductions for employees to
14 receiving parties. The database shall further provide information,
15 including, but not limited to, the following:

16 1. The school district;

17 2. The name and principal location of the entity or recipient
18 of the funds, excluding release of information relating to an
19 individual's place of residence, release of information prohibited
20 by subsection D of Section 24A.7 of Title 51 of the Oklahoma
21 Statutes, or by federal law relating to privacy rights;

22 3. The amount of funds expended;

23 4. The type of transaction; and

24 5. A descriptive purpose of the funding action or expenditure.

1 C. The Department shall make the data available on its website
2 within one hundred twenty (120) days of transmission of the
3 expenditures to the Department by the school district.

4 D. School districts shall provide information requested by the
5 Department to accomplish the purposes of this section.

6 E. Nothing in this section shall require the disclosure of
7 information which is required to be kept confidential by state or
8 federal law.

9 F. The disclosure of information required by this section shall
10 create no liability whatsoever, civil or criminal, to the State of
11 Oklahoma, the State Department of Education, or any employee thereof
12 for disclosure of required information or for any error or omission
13 in the disclosure.

14 SECTION 2. This act shall become effective November 1, 2010.”
