21 ~~BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:~~

22 SECTION 1. AMENDATORY 73 O.S. 2001, Section 15.1, as
23 last amended by Section 1, Chapter 317, O.S.L. 2009 (73 O.S. Supp.
24 2009, Section 15.1), is amended to read as follows:

1 Section 15.1 A. The Legislature shall have management and
2 control of the following space in the State Capitol Building:

3 1. The space on the third, fourth, fifth and sixth floors;

4 2. The space in the basement that is occupied by the
5 Legislature on June 1, 1995;

6 3. Approximately six thousand nine hundred thirty-nine (6,939)
7 square feet of space in the west wing of the first floor that is
8 occupied by the Department of Libraries on June 1, 1995;

9 4. Approximately six thousand six hundred ninety-one (6,691)
10 square feet of space in the west wing of the basement that is
11 occupied by the Department of Libraries and the Department of
12 Central Services on June 1, 1995;

13 5. Approximately three thousand seven hundred seventy (3,770)
14 square feet of space in the west wing of the basement that is
15 occupied by the Department of Central Services on June 1, 1995;

16 6. Approximately two thousand one hundred (2,100) square feet
17 of space in the center of the basement that is occupied by the
18 Department of Central Services and the Office of State Finance on
19 June 1, 1995;

20 7. Approximately six hundred (600) square feet of space in the
21 center of the basement that is occupied by the Department of Central
22 Services on June 1, 1995;

1 8. Approximately two thousand three hundred one (2,301) square
2 feet of space in the center of the basement that is occupied by the
3 Department of Central Services on June 1, 1995;

4 9. Approximately twelve thousand five hundred sixty (12,560)
5 square feet of space in the west wing of the first floor that is
6 occupied by the Office of the Attorney General on June 1, 2001;
7 provided, upon the Office of the Attorney General vacating such
8 space, any renovations thereto shall be made in such a manner as to
9 ensure preservation and maintenance of the cultural and historic
10 integrity of the Capitol; and

11 10. Upon completion of the project authorized in Section 332 of
12 this title, all space in the west wing of the second floor that is
13 occupied by the Supreme Court, all space in the north wing of the
14 second floor that is occupied by the Court of Criminal Appeals and
15 any other space in the State Capitol Building that is occupied by
16 the appellate courts prior to relocation to the Wiley Post
17 Historical Building; provided, the Supreme Court shall continue to
18 have exclusive management and control of the Supreme Court courtroom
19 and designated robing room located in the west wing of the second
20 floor and the Court of Criminal Appeals shall continue to have
21 access to the ~~courtrooms~~ courtroom and designated robing ~~rooms~~ room
22 located in the ~~west and north wings~~ wing of the second floor upon
23 such occasions as the ~~Chief Justice of the Supreme Court or the~~

1 Presiding Judge of the Court of Criminal Appeals deems necessary and
2 appropriate.

3 B. The authority of the Legislature to allot space may be
4 delegated to the President Pro Tempore of the Senate and the Speaker
5 of the House of Representatives. Each House of the State
6 Legislature shall have the exclusive charge of the purchase, use,
7 allotment, and disposition of its respective chambers, committee
8 rooms, fixtures, furniture, supplies, and apparatus, and shall be
9 responsible for the use and preservation of same. The provisions of
10 this section shall not prohibit the Legislature from allowing
11 agencies of the executive or judicial departments to use space
12 within the State Capitol Building that is under its management and
13 control.

14 SECTION 2. AMENDATORY 73 O.S. 2001, Section 98.6, is
15 amended to read as follows:

16 Section 98.6 Notwithstanding any other provision of law to the
17 contrary, the ~~Oklahoma Capitol Complex and Centennial Commemoration~~
18 ~~Commission~~ Legislature shall have the management and control of the
19 following space in the State Capitol Building:

20 The four offices and all space in the approximately one thousand
21 (1,000) square feet of space on the first floor in the area
22 designated as room 105, using January 1, 2001, as the reference
23 point.

24 SECTION 3. This act shall become effective November 1, 2010."
