15 AMENDMENT NO. 1. Strike the stricken title, enacting clause and
16 entire bill and insert

17 "An Act relating to schools; amending 70 O.S. 2001,
18 Section 5-142, which relates to criminal history
19 record searches by certain school districts;
20 deleting certain restrictions; modifying type of
21 criminal history record check that may be requested
22 and conducted; requiring certain criminal history
23 record check be conducted on persons seeking
24 employment; deleting certain specifications;
deleting specific content to be provided with the
request; requiring the State Board of Education to
provide follow-up information when received;
providing certain definition; and repealing 70 O.S.
2001, Section 5-142.1, which relates to criminal
history record searches by certain school districts.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 SECTION 1. AMENDATORY 70 O.S. 2001, Section 5-142, is
3 amended to read as follows:

4 Section 5-142. A. ~~The provisions of this section shall apply~~
5 ~~to a school district with an average daily membership of thirty~~
6 ~~thousand (30,000) students or less. For purposes of employment, a~~
7 ~~local~~ board of education may request in writing ~~from~~ to the State
8 Board of Education ~~information concerning any felony offense~~
9 ~~conviction~~ that a national criminal history record check be
10 conducted of any employee of the school ~~or~~ and shall request such
11 information for any person seeking employment with the school. ~~The~~
12 ~~request shall specify whether the felony record search is to be~~
13 ~~based only on the name submitted by the employee or prospective~~
14 ~~employee or on the basis of fingerprints to be required of the~~
15 ~~employee or prospective employee. The request shall further specify~~
16 ~~whether the search is to be a state or national search. If a~~
17 ~~national search is requested, the search shall be based on~~
18 ~~fingerprints, and the Oklahoma State Bureau of Investigation (OSBI)~~
19 shall obtain fingerprints of the employee or prospective employee
20 and require that ~~said~~ the person pay a search fee not to exceed
21 Fifty Dollars (\$50.00) or the cost of the search, whichever is the
22 lesser amount. The fees shall be deposited in the OSBI Revolving
23 Fund. School districts are hereby authorized to reimburse employees
24 for the cost of the search. The State Board of Education shall

1 contact the Oklahoma State Bureau of Investigation for any ~~felony~~
2 national criminal history record of ~~said the~~ person within fourteen
3 (14) working days of receiving a written request from the board of
4 education.

5 B. The Oklahoma State Bureau of Investigation shall provide the
6 ~~felony~~ national criminal history record check requested by the State
7 Board of Education within fourteen (14) working days from the
8 receipt of ~~said the~~ request. The Bureau may contact the Federal
9 Bureau of Investigation ~~as regards~~ to obtain the information
10 requested, ~~to obtain any felony convictions of the person involved.~~
11 ~~The felony record provided by the Oklahoma State Bureau of~~
12 ~~Investigation shall include the name of the person, whether or not~~
13 ~~said person has been convicted of any felony offense, a list of any~~
14 ~~felony convictions, and the dates of such convictions.~~

15 C. The State Board of Education shall provide the information
16 received from the Oklahoma State Bureau of Investigation to the
17 ~~local~~ board of education within fourteen (14) days from the receipt
18 of ~~said the~~ information. The State Board of Education shall provide
19 any follow-up information received from the OSBI concerning a person
20 for which a national criminal history record check was requested to
21 the employing board of education.

22 D. For the purpose of this section, ~~"board:~~

23 1. "Board of education" includes both public and private boards
24 of education within or outside this state; and

1 2. "National criminal history record check" means a national
2 criminal history record check as defined in Section 150.9 of Title
3 74 of the Oklahoma Statutes.

4 E. Each public board of education within this state shall
5 promulgate a statement of that school districts' policy regarding
6 felony record searches. ~~If the~~ The ~~policy requires felony record~~
7 ~~searches, the policy~~ may permit employment for not to exceed sixty
8 (60) days pending receipt of results of ~~felony search~~ national
9 criminal history record check requests. ~~If the policy requires a~~
10 ~~search based on fingerprints, prospective~~ Prospective employees
11 shall be notified of the requirement, the fee and the reimbursement
12 policy when first interviewed concerning employment. The school
13 district's reimbursement policy shall provide, at the minimum, that
14 employees shall be promptly reimbursed in full for the fee if
15 employed by the district at the time the ~~felony search~~ national
16 criminal history record check request is made unless the person was
17 employed pending receipt of results as set forth above.

18 F. Any person applying for employment as a substitute teacher
19 shall only be required to have one such ~~felony~~ national criminal
20 history record ~~search~~ check for the school year. Upon request of
21 the substitute teacher, that ~~felony~~ record ~~search~~ check may be sent
22 to any other school district in which the substitute teacher is
23 applying to teach.
