13 AMENDMENT NO. 1. Strike the stricken title, enacting clause and
14 entire bill and insert

15
16 "An Act relating to workers' compensation; amending
17 85 O.S. 2001, Section 1.2, which relates to Workers'
18 Compensation Court; modifying positions of the
19 Court; establishing permanent assignments; requiring
20 certain confirmation by the Senate; and providing an
effective date.

21 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

22 SECTION 1. AMENDATORY 85 O.S. 2001, Section 1.2, is
23 amended to read as follows:
24

1 Section 1.2 A. There is hereby created the Workers'
2 Compensation Court which shall consist of ~~ten (10)~~ eight (8) judges.
3 Each judge of the Court shall be appointed to a designated numbered
4 position on the Court. The positions shall be numbered one through
5 ~~ten~~ eight, four of which shall be permanently assigned to the
6 Oklahoma City Workers' Compensation Court and four of which shall be
7 permanently assigned to the Tulsa Workers' Compensation Court. The
8 initial terms of the judges by position number shall expire on the
9 following dates:

10 ~~Position 1 shall expire 7-1-84.~~

11 ~~Position 2 shall expire 7-1-84.~~

12 Position 3 shall expire 7-1-84.

13 Position 4 shall expire 7-1-82.

14 Position 5 shall expire 7-1-82.

15 Position 6 shall expire 7-1-80.

16 Position 7 shall expire 7-1-80.

17 Position 8 shall expire 7-1-88.

18 Position 9 shall expire 7-1-88.

19 Position 10 shall expire 7-1-96 after being appointed under the
20 provisions hereinafter set forth effective September 1, 1993.

21 Thereafter, each position shall be filled by a judge appointed
22 to serve a six-year term.

23 Provided the judges serving unexpired terms on the State
24 Industrial Court shall serve on the Workers' Compensation Court

1 until their terms expire only as provided herein. The judges of the
2 State Industrial Court whose terms expire March 14, 1979, shall
3 serve in Positions 6 and 7 until that date, and the judge whose term
4 expires March 14, 1981, shall serve in Position 5 until that date.
5 Upon expiration of these terms, the Governor shall appoint judges to
6 serve the remainder of the initial terms designated in this section.
7 When a vacancy on the Court occurs or is certain to occur or for
8 initial appointments to the Court, the Judicial Nominating
9 Commission shall choose and submit to the Governor and the Chief
10 Justice of the Supreme Court the names of three persons, in addition
11 to the name of the incumbent judge, if any, for each appointment,
12 each of whom has previously notified the Commission in writing that
13 he or she will serve as a judge if appointed. The Governor shall
14 appoint one of the nominees to fill the vacancy which shall be
15 subject to confirmation by a majority of the Senate, but if the
16 Governor fails to do so within sixty (60) days, the Chief Justice of
17 the Supreme Court shall appoint one of the nominees which shall be
18 subject to confirmation by a majority of the Senate, the appointment
19 to be certified to the Secretary of State. If the Senate is not in
20 session when the appointment is made, the Senate must confirm such
21 appointment during its next regular session. If the Senate fails to
22 confirm such appointment, the Governor shall ask the Judicial
23 Nominating Commission for the names of three persons, which shall
24 not include the name of the candidate not confirmed, and shall

1 submit a new candidate to the Senate for confirmation within thirty
2 (30) days of receipt of such nominees.

3 B. A judge of the Court shall have been licensed to practice
4 law in this state for a period of not less than five (5) years prior
5 to appointment. Each judge, before entering upon the duties of
6 office, shall take and subscribe to an oath of office and file the
7 same with the Secretary of State. Each judge shall continue to
8 serve until his or her successor has been appointed and qualified.

9 A judge shall be eligible for reappointment, provided that the judge
10 may be removed for cause by the Court on the Judiciary prior to the
11 expiration of his or her term.

12 C. Each judge shall receive a salary equal to that paid to a
13 district judge of this state, and shall devote full time to his or
14 her duties and shall not engage in the private practice of law
15 during the term in office.

16 D. The Governor shall appoint from among the judges of the
17 Workers' Compensation Court a presiding judge of that Court who
18 shall serve for a two-year term commencing with the initial
19 appointment beginning January 1, 1987. Any judge so appointed shall
20 not serve more than two times in succession. The presiding judge
21 shall preside at all hearings held by the Court, preside at such
22 meetings of the judges of the Court as may be necessary and perform
23 such other supervisory duties as the needs of the Court may require.
24 The presiding judge may designate one of the other judges to act as

1 presiding judge in his or her place whenever necessary during the
2 disqualification, disability, or absence of the presiding judge.
3 During the disqualification, disability, or absence of the presiding
4 judge, the acting presiding judge shall exercise all of the powers
5 of the presiding judge.

6 E. The Court shall have the authority to adopt reasonable rules
7 within its respective areas of responsibility including the rules of
8 procedure for the Court en banc, after notice and public hearing,
9 for effecting the purposes of the Workers' Compensation Act. All of
10 the judges of the Court shall be present at all meetings wherein
11 rules are adopted or amended. All rules, upon adoption, shall be
12 submitted to the Supreme Court, which shall either approve or
13 disapprove them within thirty (30) days. All rules, upon approval
14 by the Supreme Court, shall be published and be made available to
15 the public and, if not inconsistent with the law, shall be binding
16 in the administration of the Workers' Compensation Act.

17 F. The Court is hereby designated and confirmed as a court of
18 record, with respect to any matter within the limits of its
19 jurisdiction, and within such limits the judges thereof shall
20 possess the powers and prerogatives of the judges of the other
21 courts of record of this state, including the power to punish for
22 contempt those persons who disobey a subpoena, or refuse to be sworn
23 or to answer as a witness, when lawfully ordered to do so.

1 G. The principal office of the Court shall be situated in the
2 City of Oklahoma City in quarters assigned by the Department of
3 Central Services. The Court may hold hearings in any city of this
4 state.

5 H. All county commissioners and presiding district judges of
6 this state shall make quarters available for the conducting of
7 hearings by a judge of the Court upon request by the Court.

8 I. The judges of the Court shall determine the qualifications
9 necessary for the job of Administrator. Said qualifications shall
10 be submitted to the Chief Justice of the Supreme Court for approval,
11 disapproval or modification.

12 J. Judges of the Workers' Compensation Court may punish for
13 direct contempt pursuant to Sections 565, 565.1 and 566 of Title 21
14 of the Oklahoma Statutes.

15 SECTION 2. This act shall become effective November 1, 2009.”
