9 PROPOSED COMMITTEE SUBSTITUTE

10 An Act relating to appropriations; making an  
11 appropriation; stating purpose; amending Section 16,  
12 Chapter 287, O.S.L. 2006 (63 O.S. Supp. 2008, Section  
13 3286), which relates to the Oklahoma State University  
14 Medical Authority Disbursing Fund; specifying purpose  
of expenditures; eliminating certain conditions for  
expenditure of certain funds; and declaring an  
emergency.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. There is hereby appropriated to the Oklahoma State  
19 University Medical Authority Dispersing Fund from any monies not  
20 otherwise appropriated from the General Revenue Fund of the State  
21 Treasury for the fiscal year ending June 30, 2008, the sum of Five  
22 Million Dollars (\$5,000,000.00) or so much thereof as may be  
23 necessary to perform the duties imposed upon the Oklahoma State  
24 University Medical Authority by law.

1 SECTION 2. AMENDATORY Section 16, Chapter 287, O.S.L.  
2 2006 (63 O.S. Supp. 2008, Section 3286), is amended to read as  
3 follows:

4 Section 3286. ~~A.~~ There is hereby created in the State  
5 Treasury a revolving fund for the Oklahoma State University Medical  
6 Authority, to be designated the "Oklahoma State University Medical  
7 Authority Disbursing Fund". The fund shall be a continuing fund,  
8 not subject to fiscal year limitations, and shall consist of  
9 appropriated revenues and federal entitlements. All monies accruing  
10 to the credit of said fund are hereby appropriated and may be  
11 budgeted and expended by the Oklahoma State University Medical  
12 Authority for the purpose of operating the Oklahoma State University  
13 Medical Center and supporting the residency program of the Oklahoma  
14 State University Center for Health Sciences.

15 ~~B. Following the execution of a lease of real properties under~~  
16 ~~the jurisdiction of the Oklahoma State University Medical Authority~~  
17 ~~to the Oklahoma State University Medical Trust pursuant to Section~~  
18 ~~22 of this act, monies from the fund may be expended by the~~  
19 ~~Authority for the fiscal year ending in the year the lease is~~  
20 ~~executed, for the operations of the Authority after the execution of~~  
21 ~~the lease to the Oklahoma State University Medical Trust for payment~~  
22 ~~of any costs to the Authority associated with the transfer of~~  
23 ~~operations of facilities under the jurisdiction of the Authority,~~  
24 ~~and legal obligations of the Authority.~~

1       SECTION 3. It being immediately necessary for the preservation  
2 of the public peace, health and safety, an emergency is hereby  
3 declared to exist, by reason whereof this act shall take effect and  
4 be in full force from and after its passage and approval.
