7 PROPOSED COMMITTEE SUBSTITUTE

8 An Act relating to criminal procedure; amending 22
9 O.S. 2001, Section 152, as last amended by Section
10 130, Chapter 234, O.S.L. 2009 (22 O.S. Supp. 2009,
11 Section 152), which relates to statute of
12 limitations; increasing statute of limitations for
13 certain crime; and providing an effective date.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 22 O.S. 2001, Section 152, as last
16 amended by Section 130, Chapter 234, O.S.L. 2009 (22 O.S. Supp.
17 2009, Section 152), is amended to read as follows:

18 Section 152. A. Prosecutions for the crimes of bribery,
19 embezzlement of public money, bonds, securities, assets or property
20 of the state or any county, school district, municipality or other
21 subdivision thereof, or of any misappropriation of public money,
22 bonds, securities, assets or property of the state or any county,
23 school district, municipality or other subdivision thereof,
24 falsification of public records of the state or any county, school

1 district, municipality or other subdivision thereof, and conspiracy
2 to defraud the State of Oklahoma or any county, school district,
3 municipality or other subdivision thereof in any manner or for any
4 purpose shall be commenced within seven (7) years after the
5 discovery of the crime; provided, however, prosecutions for the
6 crimes of embezzlement or misappropriation of public money, bonds,
7 securities, assets or property of any school district, including
8 those relating to student activity funds, or the crime of
9 falsification of public records of any independent school district,
10 the crime of criminal conspiracy, the crime of embezzlement,
11 pursuant to Sections 1451 through 1462 of Title 21 of the Oklahoma
12 Statutes, ~~or the~~ shall be commenced within five (5) years after the
13 discovery of the crime. The financial exploitation of a vulnerable
14 adult, pursuant to Sections 843.1, 843.3 and 843.4 of Title 21 of
15 the Oklahoma Statutes, shall be commenced within ~~five (5)~~ seven (7)
16 years after the discovery of the crime.

17 B. Prosecutions for criminal violations of any state income tax
18 laws shall be commenced within five (5) years after the commission
19 of such violation.

20 C. 1. Prosecutions for the crime of rape or forcible sodomy,
21 sodomy, lewd or indecent proposals or acts against children,
22 involving minors in pornography pursuant to Section 886, 888, 1111,
23 1111.1, 1113, 1114, 1021.2, 1021.3 or 1123 of Title 21 of the
24 Oklahoma Statutes, child abuse pursuant to Section 843.5 of Title 21

1 of the Oklahoma Statutes, and child trafficking pursuant to Section
2 866 of Title 21 of the Oklahoma Statutes shall be commenced within
3 twelve (12) years after the discovery of the crime.

4 2. However, prosecutions for the crimes listed in paragraph 1
5 of this subsection may be commenced at any time after the commission
6 of the offense if:

7 a. the victim notified law enforcement within twelve (12)
8 years after the discovery of the crime,

9 b. physical evidence is collected and preserved that is
10 capable of being tested to obtain a profile from
11 deoxyribonucleic acid (DNA), and

12 c. the identity of the offender is subsequently
13 established through the use of a DNA profile using
14 evidence listed in subparagraph b of this paragraph.

15 A prosecution under this exception must be commenced within three
16 (3) years from the date on which the identity of the suspect is
17 established by DNA testing.

18 D. Prosecutions for criminal violations of any provision of the
19 Oklahoma Wildlife Conservation Code shall be commenced within three
20 (3) years after the commission of such offense.

21 E. Prosecutions for the crime of criminal fraud or workers'
22 compensation fraud pursuant to Section 1541.1, 1541.2, 1662 or 1663
23 of Title 21 of the Oklahoma Statutes shall commence within three (3)

1 years after the discovery of the crime, but in no event greater than
2 seven (7) years after the commission of the crime.

3 F. Prosecution for the crime of false or bogus check, Section
4 1541.1, 1541.2, 1541.3 or 1541.4 of Title 21 of the Oklahoma
5 Statutes, shall be commenced within five (5) years after the
6 commission of such offense.

7 G. Prosecution for the crime of solicitation for murder in the
8 first degree pursuant to Section 701.16 of Title 21 of the Oklahoma
9 Statutes shall be commenced within seven (7) years after the
10 discovery of the crime. For purposes of this subsection,
11 "discovery" means the date upon which the crime is made known to
12 anyone other than a person involved in the solicitation.

13 H. In all other cases a prosecution for a public offense must
14 be commenced within three (3) years after its commission.

15 I. Prosecution for the crime of accessory after the fact must
16 be commenced within the same statute of limitations as that of the
17 felony for which the person acted as an accessory.

18 J. Prosecution for the crime of arson pursuant to Section 1401,
19 1402, 1403, 1404 or 1405 of Title 21 of the Oklahoma Statutes shall
20 be commenced within seven (7) years after the commission of the
21 crime.

22 K. As used in paragraph 1 of subsection C of this section,
23 "discovery" means the date that a physical or sexually related crime
24 involving a victim under the age of eighteen (18) years of age is

1 reported to a law enforcement agency, up to and including one (1)
2 year from the eighteenth birthday of the child.

3 SECTION 2. This act shall become effective November 1, 2010.
